Agreement

Presented for Board review is the agreement for the Bullitt East High School – Baseball Dugout Expansion project between Rangaswamy & Associates, Inc. and the Bullitt East High School Athletic Boosters. The contract has been reviewed by Buckman and Farris PSC for form and legality.

As per 702 KAR 4:160, (4) advertisement and evaluation of three (3) firms shall not be required if: (a) the total construction cost of the project is estimated at less than \$1,000,000.00. With the monetary threshold being far less than \$1,000,000.00, the Bullitt East Athletic Boosters selected Rangaswamy & Associates, Inc. to perform these services.

We have been contacted by Mr. Mike Jones in regards to providing engineering services for the referenced project. Our services shall include:

- 1. Provide project drawings and specifications required for Kentucky Department of Education and Bullitt County Code Enforcement submission and approval.
 - a. Foundation and wall design will be included in the project drawings and specifications. Roof truss drawing will be provided by the roof truss manufacturer. RAI will review the roof truss drawings and connection details.
 - b. Mechanical design and engineering for HVAC and plumbing will not be provided at this time. We can provide those services as needed for an additional fee.
 - c. Electrical design will be by the electrical contractor and will comply with the code minimum requirements.
- 2. Review all necessary shop drawings required.
- 3. Perform three site visits for project construction observation/review of foundations, walls, and roof framing.

Rangaswamy & Associates, Inc. will perform these services at our standard hourly rates of \$125/hr for Structural Engineer and \$100/hr for Project Manager, not to exceed the total amount of \$2000.00.
