RE: Board Agenda Item – Building Modification – Bernheim Middle School

Presented for Board approval is a request from Bernheim Middle School to create an individualized, practice room for band students.

The request involves modifying (2) two existing doors that serve the band instrument storage room by adding 10"x38" viewing glass to each door. This will allow students to use the space for independent instruction while providing visible observation for the band instructor. Currently, there are limited opportunities for students to sharpen their playing skills outside of a group setting. This will give individual students this much-needed opportunity.

The district's maintenance team has met with Ms. Katie Stephens and has determined that the doors are not fire-rated and can be modified. The district maintenance team will install the viewing glass. Funding to purchase the view glass will come from Bernheim's Fund 22 account. WillisKlein will provide the viewing glass at a cost of \$359.00.

I recommend the Board approve the request from Bernheim Middle School to create an individualized, practice room for band students.

Board Members,

Bernheim Middle School would like to modify the doors on the band instrument storage room. Our intent is to convert the room into a student practice room. The way the band area is currently set up, students have limited time and space for individualized instruction. Creating a practice room will provide the opportunity for students to sharpen their skills on their particular instrument and, collectively, strengthen the band as a whole.

After working with the maintenance department, it has been determined that the doors are not fire-rated and can be modified. We are requesting to install 10" x 38" windows in (2) two doors which will allow for visual observation and independent instruction. The windows will be purchased through WillisKlein at a cost of \$359.00. Funding is found in Bernheim's Fund 22 account.
