The school failing to carry out the terms of the contract shall pay to the other the listed forfeit fee per contest remaining on the contract unless the contest(s) is/are canceled by mutual consent. It is the financial responsibility of the school failing to carry out the terms of the contract to pay the officials fees in addition to any applicable forfeit fee. If a forfeit fee is paid for cancellation of the contest after the first legal playing date, the victory/defeat shall be made part of the won-loss record of both teams and count on the limit of games for both teams. 4. In case of inclement weather or for other documented emergency reasons beyond school administrative control the principal of either school shall have the privilege of canceling the contest up to how many hours before the time set for the start of the contest? All expenses incurred by the visiting team or game officials through failure of the home team to notify the visiting team of the cancellation in a timely manner shall be paid by the home school.
