Kentucky Community and Technical College System Renewal

The current lease with Kentucky Community and Technical College System (KCTCS) for the Buffalo Run facility is scheduled for renewal on July 1, 2018. You will find the lease agreement attached. This is an annual renewal for the majority of the space at Buffalo Run. Other agencies lease a small portion of the facility as well and their leases are handled separately. I ask the lease with Kentucky Community and Technical College System be renewed for one year effective July 1, 2018.
