SBDM Minutes
March 22, 2018

Principal Ryan Kellinghaus called the March 22, 2018 SBDM meeting to order at 4:05 pm in Room 119. Members present included Ryan Kellinghaus, Julie Rubemeyer, Angie Buschle, Erin Goetz, and Angela Gonzalez. Also present were Brad Campbell, Dillon Mears, Rian Embry, Steven Schwartz, Lisa Klette, Angie Boyers, and Candy Tucker.

Angie Buschle made a motion to accept the agenda. Erin Goetz seconded the motion. All members approved.

Julie Rubemeyer made a motion to accept the February 22nd minutes with the changes. Angela Gonzalez seconded the motion. All members approved.

Committee Reports

Science

- Lisa Klette reported on her Science Classes. Her 7th grade Science classes have 4 students failing, and no 8th grade students failing. She has homework help every Monday, makes parent phone calls, works Friday school every week and is available for help multiple other days after school.
- David Whittington was not present and the video he made was not working. The paperwork he provided did show that none of his Environmental Science students nor his Honors Physics students are failing. In his 6th period Chemistry class there are 4 students failing and in his 7th period Chemistry class there are 2 students failing. He has had student conferences with these students and told them about their missing assignments, but they have not completed the assignments.
- Alex Laufmann reported on his Integrated Science classes. He has 3 students failing in his 2nd period, no students in his 4th period, and 2 students failing in his 5th period classes. In his Biology classes, he has 3 students failing, no students in his 6th period, and 2 students failing in his 7th period classes. He is here on Mondays and Tuesdays after school to go over missed work, or reteach or retest assignments or tests.
- Brad Campbell reported on his Integrated Social Studies classes. He has 1 student failing in his 2nd period, no students in his 6th period, and 3 students in his 7th period classes. In his US Survey class, he has no students failing. He has student conferences, makes parent phone calls, has academic detentions, does Friday School and does differentiated instruction.
- Dillon Mears reported on his US Survey class. He has 3 students failing. In his US History 3 period class he has 3 students failing, and no students failing in his 7th period class. In his Film and Lit 6th period class he has 3 students failing. He also does student conferences, parent phone calls, and academic detentions.

- Julie Rubemeyer reported for her and Beth Fields on 8th grade Social Studies. There is only 1 student failing. In 7th grade Social Studies Ms. Fields reported there are 4 students failing. They have had student conferences, made parent phone calls, had academic detentions where they reteach or had students retake assessment, and done Friday School. They have had one on one help after school, and at lunch. They are also available Tuesdays and Thursdays by appointment during softball season.
- Steven Schwartz reported on his Music classes. He reported this week because of missing his reporting week. In his Middle School Band class he has one student failing because they forgot their instrument for 3 tests. In his Guitar classes he has 3 students failing. In his Percussion class and in his High School Band classes he has no failing students. He does one on one, makes phone calls home, has partner, group or sectional work, and does retakes.
