1. **TERM** - This contract shall continue for the above stated period and shall automatically renew for an additional year (contest) unless a party notifies the other party in writing that the contract will not renew. This written notice shall be given no later than the date falling six (6) months after the last contest scheduled under this contract.
2. **OFFICIALS** - Contest officials shall be selected and paid by the host. The host shall engage the contest official(s) using the designated IHSAA Contract for Contest Officials form. The decisions of the contest officials are final and are not subject to protest, review or appeal, accept as permitted by the playing rules of the sport involved.
3. **CONDITIONS** - The schools agree to the following:
 - a. All IHSAA By-Laws, Rules, Regulations and Policies are incorporated into this contract.
 - b. If a school has its IHSAA membership suspended or terminated, the other school may terminate this contract and be entitled to a termination fee, as described in 3(c).
 - c. A school which fails to fulfill their terms of this contract, except (i) when the school cannot fulfill the terms because of circumstances outside the control of the school, or (ii) by mutual consent, shall pay a termination fee to the other school. The termination fee shall be in an amount as agreed by the schools, but if the schools are unable to agree, the termination fee shall be the greater of \$1000 per basketball contest, \$1000 per football contest, \$500 per contest in any other sport, or the average home game, in that sport, of the school which has fulfilled the terms of this contract. The foregoing notwithstanding, either school can request the IHSAA intervene and the schools agree that the IHSAA can establish any termination fee and make any adjustment it deems appropriate.
