Scientific Learning Corporation National Leadership Center Program Agreement

Scientific Learning Corporation ("SLC") has established a National Leadership Center program to recognize a limited number of sites around the country that demonstrate excellent implementations of the Scientific Learning products combined with exceptional student results. SLC and the school district named above ("District") have agreed that District will participate in SLC's National Leadership Center program, on the terms provided below.

For the term of the Agreement, SLC will provide the following:

1. Dedicated regional National Leadership Center contact.
2. Sponsorship of one major activity per year, as mutually agreed upon by the District and SLC. Examples of a major activity are: a complimentary one-day professional development seminar for District staff, a presentation about Fast ForWord and Reading Assistant products to community leaders, or a celebration for Fast ForWord and/or Reading Assistant students.
3. For the Showcase Site(s) specified above only, one web-delivered training session will be available each year during the term of the Contract.
4. In order to qualify for the complimentary licenses and the discount stated above, the District must purchase and pay for Fast ForWord support during the full term of this Contract.

During the term of the Agreement specified above, the District agrees to the following:

1. To be a National Leadership Center with exemplary educational leadership and Scientific Learning product implementation.
2. **Research / Product / Implementation Studies**
The District will be asked to conduct a research, product and/or implementation study during the term of this agreement.
 - a. **Research Study:** A randomized comparison trial study where half the students in the study are randomly assigned to use a specific SLC product & implementation, while the other half use the regular classroom curriculum.
 - b. **Product Study:** Product field testing
 - c. **Implementation Study:** Studies of specific product implementation under defined environments

3. **Reports and Data.** SLC may create reports from the data that the Site provides to SLC relating to the Site's use of SLC products (in the study described above, in other studies in which the Site may participate or otherwise). SLC is authorized to make these reports available on SLC's website, distribute the reports to persons interested in SLC products, and include quotes, excerpts and summaries of the data from the reports, including the Site's name, in SLC materials that describe the results that can be achieved from using the products. Student names will not be identified in any published reports. Only SLC's employees and agents will have access to any personally identifiable information provided to SLC by the District.
4. **Quotes and Photographs.** The District will assist SLC in obtaining statements about SLC products from teachers, administrators and students (with parental permission) at the site, and will allow SLC to photograph and videotape teachers, administrators and students (with parental permission) in conjunction with SLC products. The site will work actively with SLC to obtain the authorizations and releases (informed consent) necessary for the publication and use of the statements and images in SLC materials.
5. **Marketing.** The District will participate, at SLC's request, in the creation of marketing tools/materials such as DVD's, CD's, brochures, pamphlets, etc., and hereby gives SLC permission to share any such tools and materials with the public and to edit and excerpt from such materials. If the District requests, in any material that includes the District name and that is used publicly, SLC will state that the material does not constitute an endorsement of SLC products by the school district. Student and staff names, images, and voices will be used only with prior written consent of the person in question, or, for minor students, their parents. The District will assist SLC in obtaining any necessary signed authorizations from any students (or their parents) and for staff whose images, voice, or names are proposed to be included in any such materials.
6. **Surveys.** The District will complete periodic surveys from SLC.
7. **Reference Calls and Visits.** During the term of the Contract, the District primary contact and/or secondary contact listed on this contract will take calls and permit visits from prospective Fast ForWord customers to permit those customers to observe and ask questions about the District's implementation of SLC products. The District primary contact and/or secondary contact listed on this contract will track the dates of such calls and visits and the prospective customers involved, and provide that information to SLC on request.
8. **New Products.** At SLC's request, the District will participate in Beta and field trials of new SLC products and provide SLC with its results of those tests.
9. **Presentations.** Upon SLC's request, up to two District personnel will present at two conferences or events – national, state or SLC internal -- on behalf of SLC. For such conferences or events, SLC will reimburse the District for up to two District personnel for reasonable conference or event registration fees, travel costs, and lodging costs for up to three nights and a food stipend for up to three days, in accordance with SLC's standard expense reimbursement policies.
