II.A.1. Project Updates - BHS Bleachers; Vestibules

Mike Sparkman and Victor Smith with alt32 Architecture Firm reviewed the items up for approval on this agenda, including the construction documents for the BHS Bleacher Replacement project, noting that the bleachers will be purchased through a bid from KEDC, expediting the process somewhat. They also reviewed the proposals for surveying the ATC site and recommended that the board approved Endriss Engineering to do the survey. This survey will improve the planning process for the ATC and provide necessary information to the design phase. The architects then reviewed the BG for the security vestibules and the schematic design for each school including BHS, Marie Roberts-Caney, and Highland-Turner. The total cost of this project is estimated to be around \$56,000.
