#### **Strengths**

- Overall teacher satisfaction for central office and superintendent increased by 36%
- Overall teacher satisfaction for JCPS management of funds increased by 20%

#### A Positive School Climate/Culture is related to:


- Higher Student Engagement

More than 94,000 parents, students and staff participated in Comprehensive School Survey. Including 72 schools with over a 90% response rate for both students and teachers.






