# MEMORANDUM OF AGREEMENT

---

## BETWEEN JAG KY AND LIVINGSTON COUNTY SCHOOLS

### SPECIAL INCENTIVE INVESTMENT – DELTA REGIONAL AUTHORITY

The Delta Regional Authority has made available incentive investments to implement the Jobs for America's Graduates Model at the highest levels of fidelity to the Model, based on its proven success across the DRA footprint over many years.

In consideration of the investment from the Delta Regional Authority through JAG KY and Livingston County Schools, said school district hereby agrees to:

1. Provide the additional resources needed to have a full-time staff member serving 25-35 of the school's youth eligible for the Jobs for America's Graduates program as defined by JAG KY in Livingston County High School in the 2018-2019 school year. That commitment includes having the staff member working in the summer to help assist the young people into jobs, college, or some combination.
2. Meet the minimum Process and Outcome standards of the Jobs for America's Graduates Model as defined by Jobs for America's Graduates, Inc.
3. Have the staff member responsible for conducting the Jobs for America's Graduates Model in the Livingston County High School program available for requested training and development activities as part of the commitment to the fidelity of the JAG Model.
4. Make its best efforts to work with Jobs for America's Graduates to secure the resources needed to sustain the Jobs for America's Graduates program in the 2018-2019 school year from either or both the internal and external sources, working in close cooperation with JAG KY.
5. In turn, the JAG KY agrees to arrange and schedule pre-service and in-service training, the delivery of the whole Jobs for America's Graduates National Curriculum; the implementation of the Jobs for America's Graduates research and tracking system (the JAG Electronic National Data Management System – e-NDMS) which shall be updated at least every two days by the JAG Specialist assigned to the JAG program implemented as a result of these funds; the JAG Career Association activities; ongoing supervision; technical assistance; and troubleshooting to help assure the highest levels of implementation consistent with the Process and Outcomes standards of the High School Model of Jobs for America's Graduates. It is understood that (*matching partner/state dept. of ed.*) and Delta Regional Authority may withdraw its funding and all parts of the



Jobs for America's Graduates Model delivered to Livingston County Schools if, after efforts at remediation, the Livingston County High School is unable or unwilling to take the actions necessary to assure high-quality delivery of the Model of Jobs for America's Graduates, Inc.
