MEMORANDUM OF AGREEMENT BETWEEN ROWAN COUNTY, KENTUCKY AND CITY OF MOREHEAD, KENTUCKY

WITNESSETH, THAT:

WHEREAS, the County is desirous of contracting with the City for the administration of its business licenses and the administration and collection of its occupational taxes;

NOW, THEREFORE, in consideration of the premises aforesaid and in further consideration of the mutual promises, covenants, and agreements herein and in consideration of the mutual benefits to the County and the City, the parties hereby agree as follows:

Section 1: Duties

The City shall provide administration and execution of the County's occupational and net profit tax ordinance which shall include receiving applications for and issuing business licenses upon request, sending reporting and collection documents to license holders, receiving tax payments and supporting documentation, recording and depositing said payments in the banking facility designated by the County, providing the County Treasurer with deposit slips and supporting documentation, and communicating and providing reports to the County as requested.

Section II: Term

This Agreement shall be effective from July 1, 2018 to June 30, 2019.

Section III: Compensation

For services rendered under this Agreement the County shall pay to the City the sum of \$2,333.33 monthly for the first eight months and \$2,333.34 for the remaining four months of the contract, said payments being due to the City on the 10th day of each month for a total of \$28,000.00. In addition to said compensation, the County shall be responsible for all incidental expenses related to the administration and execution of the County's Occupational and Net Profit

Tax Ordinance. In the event the parties wish to renew this agreement, then compensation may be adjusted based on the previous agreement adjusted by the CPI index issued annually to local governments by the Commonwealth of Kentucky.

Section IV: Confidentiality

All data or information concerning the business activities of the County which the City acquires in connection with, or as a result of the performance of services for the County shall be kept secret and confidential by the City employee assigned to said duties and shall be revealed only to the designated County official. This covenant of confidentiality shall extend beyond the terms of this Contract and shall survive the termination of this Contract for any reason.

Section V: Severability and Limited Enforceability

It is understood and agreed, that should any portion of any clause or paragraph of this Agreement be deemed too broad to permit enforcement to its fullest extent, then such restriction shall be enforced to a maximum extent permitted by Law, and the City and County hereby consent and agree that such scope may be modified accordingly in any proceeding brought to enforce such restriction. Further, it is agreed that should any provision in this Agreement be entirely unenforceable, then the remaining provisions of the Agreement shall not be affected thereby.

Section VI: Governing Law

This Agreement shall be governed by, and construed under and in accordance with the laws of the Commonwealth of Kentucky.

Section VII: Assignment

This Agreement and the rights and obligations hereunder may not be transferred, pledged, encumbered, assigned, anticipated or alienated by either party.

Section VIII: Termination

Either party may terminate this Agreement by giving at least a six (6) month notice to the other party of its intention to terminate this Agreement. Said notice must include a copy of the resolution of the Board of City Council or the Fiscal Court authorizing termination.

Section IX: Notice

All notices between the parties relating to this Agreement shall be in writing, effective when delivered, or if mailed, effective on the second day following mailing, postage prepaid, to the address for the party stated below or to such address as either may specify by notice to the other:
