CONTRACT FOR NONRESIDENT PUPILS
2018- 2019 School Year



Instructions:

1. Contracts are required by KRS 157.350, which reads in part: "Each district which meets the following requirements shall be eligible to share in the distribution of funds from the fund to Support Education Excellence in Kentucky...(4) Includes no nonresident pupils in its average daily attendance, except by written agreement with the district of the pupils legal residence..."
2. This contract is to be made in duplicate. Each district is to keep a signed copy on file.
3. The board of education of the district where the nonresident pupils attend school agrees to make attendance reports at the close of the first two (2) months and at the close of the school term. These reports shall be delivered to the board of education where the pupils legally reside and shall agree with the terms of this contract.
4. The board of education of the district of residence and the board of education of the district providing instruction agree that all contractual terms, supplemental agreements, and other conditions governing this exchange of students are herewith fully disclosed. Copies of all such contracts, agreements, and conditions are attached and made part of this contract for nonresident pupils.
5. Do either parents or either board of education pay tuition for nonresident children? ☐ YES ☐ NO. If "YES", attach a statement disclosing the tuition rate, to whom it is paid and the payment terms.
6. One of the following criteria must be met before a nonresident pupil is enrolled in the Newport Independent School District (NISD):
 - A. Child of an employee of the NISD
 - B. Child with special needs based on arrangements per Admissions and Release Committee (ARC)
 - C. Tuition student
 - D. Child enrolled in the NISD, who has moved out-of-district during the school year. Acceptance is decided on a case-by-case basis.
- I The board of education of the **SOUTHGATE INDEPENDENT** school district (district of legal residence of pupils) enters into a contract with the board of education of the **NEWPORT INDEPENDENT** school district (district where the pupils attend) to educate pupils who meet established criteria as stated above (list attached). This contract further provides that the average daily attendance of the pupil(s) is to be counted in the district where the pupil(s) attend school.
- II The board of education of the **NEWPORT INDEPENDENT** school district is to receive transportation credit for **ANY/ALL** pupils reported in Part I, such credit to be calculated in accordance with KRS 157.370.

Admission of Out-of-District Students**ADMITTANCE CRITERIA**

Newport Independent Schools shall admit pupils who reside out of the Newport School District based upon an application for admission duly submitted to the Office of the Superintendent. The Superintendent shall have discretion to allow or deny admission based upon criteria which include the analysis of the out-of-district pupil's past academic performance, as shown in transcripts to be provided by the applicant, the age of the child and the grade to be attended, the attendance history of the out-of-district pupil, and the availability of resources within the district to accommodate the existing student body as well as the out-of-district pupil.

APPEAL TO BOARD OF EDUCATION

If an applicant for admission, as set forth above, is denied by the Office of the Superintendent, said applicant may petition the Board of Education for a final decision on the question of admission.

BUSING NOT REQUIRED

Nothing within this policy shall be construed as requiring the Newport Board of Education to provide bus service outside the geographic parameters of the Newport Independent School District.
