Add-on Services

Onsite Training Session(s)* Onsite training sessions are for a maximum of 15 attendees and should be held in a computer lab with a projector or in a room with sufficient wireless in the case that attendees bring their own laptops. Onsite trainings include up to six hours of instruction per day with a Schoolology Trainer; a Professional Development Team member will work with you to plan your onsite session(s) using Schoolology's course catalog as a planning guide. Travel and Expenses are included in the purchase of an onsite training day. Onsite training days require at least 14 days of lead time to accommodate for travel arrangements. Cancellations could result in the payment of expenses by Trigg County Schools if fees for arrangements have already been encumbered. If training is requested less than 14 days then Trigg County Schools could be held responsible for fees in excess of average travel costs.

*Training services will expire one (1) year from contract start date.

Consulting Services - Virtual*

Trigg County Schools has purchased virtual consulting time. Your Client Success Manager (CSM) will work with you to plan the use of the time appropriately. Virtual consulting is per hour and includes meeting and work time with an individual from the Schoolology team. This service can be used for further planning for driving adoption throughout your organization, extra guidance around Schoolology best practices, or evaluating unique integration needs.

*Consulting Services time will expire one (1) year from contract start date.
