

The Newport Board of Education held a special meeting on May 23, 2018 at 5:45 P.M. The meeting was held in the Board Room located at 30 W. 8th Street, Newport. Purpose: Expulsion Hearing

CALL TO ORDER

Chairman Malone called the meeting to order and asked for a roll call. The following were present: Ramona Malone, Dr. Julie Smith-Morrow, Theresa Miller, & Matt Scott.

EXPULSION HEARING

The board found there was clear and convincing evidence of abuse of a teacher, classified employee, or school administrator and disorderly conduct in the 2^{nd} degree. The decision was made to expel student from all schools and school activities for one calendar year without services.
