Dear Ms. Witt:

As Metro United Way completes our 100th year of helping to improve lives in our community, we're proud of our strong partnerships with organizations like yours to help everyone in our community achieve their full potential. Our commitment to fight for the education, financial independence and health of every person in each of the seven counties we serve is unwavering and stronger than ever. We're proud of the impact we are creating and grateful for your partnership to build a brighter, stronger and more vibrant community where every child, individual, and family has the opportunity and ability to thrive.

Recently, we celebrated the final results of our 100th anniversary campaign, which raised \$36 million. The 100th anniversary campaign goal was to increase the annual campaign to \$27 million, to reserve \$2 million for an upgrade fund to invest in the technology needed to sustain our work over time, and to increase the MUW endowment by \$7 million. The annual campaign supports our investment in effective organizations like yours. In addition, it provides the operating support for MUW to lead our community in addressing our most pressing needs. Some time ago, we launched a redesign of our community investment practices to help strategically focus our resources in the years ahead. We are continuing the process with a goal of implementation in the spring of 2019.

This letter serves as notification of Metro United Way's annual campaign investment in your agency of \$76,020.00. The attached document details the funds allocated to you, but please remember that our ability to pay out the investment dollars is contingent upon our ability to collect the funds pledged. In addition, payments will be released from our account at month's end, beginning July 2018 through June 2019. As in the past, although Metro United Way has raised the full amount of your investment, many companies choose to employ third-party donation processing vendors to process their campaigns.
