# AMENDED AGREEMENT

## Supplement I

WHEREAS, the Boards of Education of: Oldham, Trimble, Henry, Eminence Independent, Shelby, Spencer, and Bullitt previously executed an interlocal agreement pursuant to the terms and provisions of KRS 65.210 to 65.310, which was approved by the Superintendent of Public Instruction and the Attorney General of Kentucky, creating an entity known as Education Development Region VI.

WHEREAS, the above named character members now desire to amend the original interlocal cooperation agreement creating Education Development Region VI to provide as follows:

- The parties desire to change the name of the organization created in the original agreement from Education Development Region VI to Ohio Valley Educational Cooperative. All references in the original agreement to Educational Development Region VI shall now appear as Ohio Valley Educational Cooperative.
- Section IX of the original agreement is hereby amended to read as follows: Other school districts may engage in this cooperative agreement by the passage of a resolution complying with the conditions of this agreement. However, the addition of a new member district is subject to the approval of the Ohio Valley Educational Cooperative Board.
- Section X of this original agreement is hereby amended to read as follows: This agreement shall become effective after approval and execution by the participating boards of education and upon approval by the Kentucky Attorney General. This Interlocal Cooperation Agreement is entered into pursuant to the authority of KRS 65.210-65.310, inclusive.

Section IX of the original agreement provides that additional school districts may engage in this agreement by passage of a resolution complying with the conditions of the agreement. The Anchorage, Carroll, Gallatin, and Owen School Districts have indicated their desire to engage in this agreement and having passed the appropriate resolution to present members hereby accept them as members for the purposes set forth in the original agreement. The Anchorage, Carroll, Gallatin, and Owen School Districts accept the provisions of the amended agreement and all the other terms and provisions of the original agreement hereby incorporated by reference.

# INTERLOCAL COOPERATION AGREEMENT Educational Development Region VI

#### DECLARATION OF INTENT

WHEREAS, the parties to this agreement deem it mutually advantageous to provide certain services, programs and/or facilities to the children, youth and adults of their respective school districts as subsequently provided herein; and

WHFREAS, by this mutual agreement, such services, programs and/or facilities can be provided better collectively rather than individually; and

WHEREAS, the objectives of Regional Service Agency, Region VI are:

1. To make educational programs and services available on a regional basis.

 To serve as a model of administrative practices which will enable participating districts:

- (a) To analyze educational problems and devise solutions in an orderly, rational manner.
- (b) To reallocate resources in order to achieve desirable educational results.

3. To bring resources of other organizations, particularly the Department of Education and institutes of higher education, to bear upon the problems of participating districts.

NOW, THEREFORE, there is hereby created a separate administrative board as an entity for Educational Development Region VI.

The conditions of the Regional Service Agency, Region VI Interlocal Cooperation Agreement are as follows:

#### I. CHARTER MEMBERS

The following school districts, having passed resolutions to participate in a cooperative effort and recorded said resolutions in the Board minutes, shall constitute the participating charter members to this agreement:

> Oldham County Trimble County Henry County Eminence Independent Shelby County Spencer County Bullitt County

#### II. GOVERNING BODY

This agreement shall be administered by the Regional Service Agency, Region VI Board which shall be composed of: (a) the superintendents of the school districts participating herein, (b) a representative of Area Development Districts serving the region, (c) a representative of the area community colleges and/or regional university, (d) a representative of the State Department of Education, (e) a representative from Regional Manpower Commission, and (f) a representative from the regional vocational advisory committee, except that the number of superintendents voting on issues must exceed by one or more, the combined voting members representing other agencies. members have voting privileges only when participating in programs to which they contribute personnel or other resources, or programs in which pupils in their school district directly benefit.

### A. QUALIFICATIONS AND SELECTION PROCEDURES

- (1) The superintendents who serve on the Board of Directors shall be the superintendents of the participating districts.
- (2) The representative of the Area Development District shall be appointed by the Executive Director of that agency to serve at his pleasure.
- (3) The representative of a university or community college shall be appointed by the president or his designee to serve at his pleasure.
- (4) The representative of the State Department of Education shall be appointed by the Superintendent of Public Instruction.
- (5) The representative from the vocational advisory committee shall be appointed by the committee.
- (6) The representative of the Manpower Commission shall be appointed by the Commission.
- (7) No member shall be permitted to vote by proxy.

#### B. DUTIES OF GOVERNING BODY

The Board shall have general control and management of such programs and services as it deems necessary for the promotion of education and the general health and welfare of pupils, consistent with the State Constitution, Kentucky Revised Statutes and the rules and regulations of the State Board of Education. The Board shall have power to accept funds from both public and private sources, employ personnel, make purchases, and do all things necessary and proper to carry out the full intent and purposes of this agreement.

## III. PURPOSE

The basic purpose of this agreement is <u>to provide a</u> <u>vehicle for conducting area educational planning, development and</u> <u>implementation on a continuing basis and to operate programs and</u> <u>provide services for the mutual benefit of the children and youth</u> of the school districts participating herein.

IV. SELECTION OF PROGRAMS AND SERVICES

Regional Service Agency, Region VI shall have the authority to select and determine the educational programs and services which will be provided.

#### V. FINANCIAL RESPONSIBILITY

The Board of Directors shall have general responsibility for the receipt, disbursement and accountability of any funds for the execution of this agreement.

#### VI. COSTS OF PROGRAMS AND SERVICES

Other than those programs fully funded from other sources, each board of education will pay its pro rata share of the costs of the programs and services. The pro rata costs shall be determined as follows: The costs of any program to a school district will be derived by dividing that district's number of pupils participating in the program by the total number of pupils participating in the program and multiplying by the total cost of the program. The Board, subject to ratification of the participating school districts, may modify this formula for particular programs.

#### VII. TERM OF AGREEMENT

This agreement shall become effective <u>January 1, 1975</u> and extend to June 30, 1976. The agreement shall be renewed automatically for subsequent fiscal years unless any district desiring not to participate provides written notification to the Regional Service Agency, Region VI Board not less than thirty (30) days before June 30 of any year. Upon withdrawal of a participating school district, that school district may sell its share of all personal and real property to any willing buyer who is acceptable to a majority of the Board.

#### VIII. JOINT PROPERTY

All personal and real property acquired under this agreement shall be considered the joint property of all participating districts and shall be held in trust by the members of the Board of the Regional Service Agency, Region VI, providing

proper declaration and explanation of the trust is in the deed instrument, and upon dissolution, each participating district will receive its proportionate share of the real and personal property in accordance with their proportionate payment made to the securing of the property or properties.

### IX. NEW MEMBERSHIP

Other school districts may engage in this cooperative agreement by the passage of a resolution complying with the conditions of this agreement. However, the addition of a new member district is subject to the approval of the Regional Service Agency, Region VI Board of Directors. In the event a controversy arises concerning the admission of a new member district, the matter shall be resolved by the State Superintendent of Public Instruction.

## X. APPROVAL

This agreement shall become effective after approval and execution by the participating boards of education and upon approval by the State Superintendent of Public Instruction and the Kentucky Attorney General. This Interlocal Cooperation Agreement is entered into pursuant to the authority of KRS 65.210 - 65.300, inclusive.

### AMENDMENT TO INTERLOCAL COOPERATION AGREEMENT OF

### **OHIO VALLEY EDUCATIONAL COOPERATIVE**

THIS AMENDMENT TO AN INTERLOCAL AGREEMENT (the "Amendment" or Amended Agreement") is entered by and among the Superintendents and Members of the Board of Directors of OHIO VALLEY EDUCATIONAL COOPERATIVE (OVEC).

### WITNESSETH:

WHEREAS, the Boards of Education of Anchorage Independent, Bullitt, Carroll, Eminence Independent, Gallatin, Henry, Oldham, Owen, Shelby, Spencer, Trimble, and West Point Independent previously executed an interlocal agreement pursuant to the terms and provisions of KRS 65.210 to 65.300, as approved on April 24, 1975 and as amended and approved by the Superintendent of Public Instruction and the Attorney General of Kentucky, creating an entity known as Ohio Valley Educational Cooperative (OVEC) on November 17, 1976, and which is filed with the Secretary of State of Kentucky and the appropriate County Court Clerks pursuant to the provisions of the ACT, and

WHEREAS, the Grant County Board of Education has recently voted to join Ohio Valley Educational Cooperative and have ratified the interlocal agreement, and

WHEREAS, the above named boards of education deemed it mutually advantageous to provide certain services, programs, and facilities to the children of their respective school districts through the utilization of a cooperative organization to be known under the Original Agreement as Educational Development Region IV and now known as Ohio Valley Educational Cooperative (OVEC) under the Amended Agreement and

WHEREAS, the Board of Directors of Ohio Valley Educational Cooperative has determined that it is necessary and desirable for the purposes of Ohio Valley Educational Cooperative to: 1) acquire, construct, reconstruct, renovate and improve certain building facilities for and on behalf of Ohio Valley Educational Cooperative consisting of the acquisition, construction and equipping of a central office or headquarters facilities; and ii) acquire by purchase or lease, equipment, furniture and fixtures for use by Ohio Valley Educational Cooperative staff and/or the Board of Directors in fulfilling the purpose of Ohio Valley Educational Cooperative, collectively to be referred to as "Project", and

WHEREAS, the Board of Directors of Ohio Valley Educational Cooperative has determined it is necessary and desirable that the Original Agreement as amended clearly demonstrate the legal authority of Ohio Valley Educational Cooperative to finance the Project and said Amendments have been approved by the Board of Directors at a regular meeting and by resolution by each of the above named local boards of education. NOW, THEREFORE IT IS AGREED BY THE MEMBER SCHOOL DISTRICTS EXECUTING THIS AMENDMENT THAT THE ORIGINAL INTERLOCAL COOPERATION AGREEMENT BE AMENDED AS FOLLOWS:

#### ARTICLE XI. Approval of Debt Obligations

The maximum indebtedness of liability which the Ohio Valley Educational Cooperative may at any time incur is unlimited, and its property shall not be used or applied for the payments of its debts and liabilities lawfully incurred.

Ohio Valley Educational Cooperative shall incur no indebtedness or liability except upon a favorable vote from two-thirds of the membership of the Board of Directors at a regular meeting as reflected by Ohio Valley Educational Cooperative's Minutes of the Board of Directors. In connection with the incurred indebtedness, such provisions may be inserted in the papers authorizing same as may be necessary for the protection of the holders of indebtedness and without limiting the generality of the foregoing, Ohio Valley Educational Cooperative may issue or assume from time to time separate bond issues, notes, or other evidence of indebtedness, including leases, with such separate or combined security and with such restrictions as the Board of Directors may deem for the best interest of Ohio Valley Educational Cooperative.

The private property of the members of the Board of Directors or the school districts, or the public universities, constituting the membership of said Board of Directors shall not be subject to or in any way liable for any debt or contract of Ohio Valley Educational Cooperative.

### Article XII Financing Agency Authorized

That for the purposes of acting as an agency and instrumentality of Ohio Valley Educational Cooperative for financing purposes the Board of Directors is authorized to incorporate Ohio Valley Educational Cooperative Finance Corporation (or such other designation as the Board of Directors of the Ohio Valley Educational Cooperative may determine) pursuant to the provisions of Section 58.180 of the Kentucky Revised Statutes; said Corporation hereinafter being referred to as the Finance Corporation.

The affairs and business of the Finance Corporation shall be conducted by its members, who shall constitute the governing body of the Finance Corporation, to be known as its Board of Directors and shall be the same persons who are, at the time business is conducted, the members of the Board of Directors of the Ohio Valley Educational Cooperative in accordance with the Bylaws of the Ohio Valley Educational Cooperative. Upon any member of the Board of Directors of the Ohio Valley Education ceasing to be a member of the Board of Directors of the Ohio Valley Educational Cooperative shall no longer be a member of the Finance Corporation's Board of Directors.

The officers of the Finance Corporation shall consist of a chairperson, a secretary, a treasurer, and such vice-chairpersons as the Board of Directors may elect.

#### AMENDMENT TO THE INTERLOCAL COOPERATION AGREEMENT OF THE

#### **OHIO VALLEY EDUCATIONAL COOPERATIVE**

THIS AMENDMENT TO AN INTERLOCAL AGREEMENT (the "Amendment" or Amended Agreement") is hereby entered by and among the Superintendents and Members of the Board of Directors of the OHIO VALLEY EDUCATIONAL COOPERATIVE (OVEC).

#### WITNESSETH:

WHEREAS, the Boards of Education of Anchorage Independent, Bullitt County, Carroll County, Eminence Independent, Gallatin County, Grant County, Henry County, Oldham County, Owen County, Shelby County, Spencer County, Trimble County and West Point Independent previously executed an Interlocal agreement pursuant to the terms and provisions of KRS 65.210 to 65.300, as approved on April 24, 1975 and as amended and approved by the Superintendent of Public Instruction and the Attorney General of Kentucky, creating an entity known as the Ohio Valley Educational Cooperative (OVEC) on November 17, 1976, and amended and approved by the Commissioner of Education and the Attorney General of Kentucky on November 30, 1994, and which is filled with the Secretary of State of Kentucky and the appropriate County Court Clerks pursuant to the provisions of the ACT, and

WHEREAS, the Franklin County Board of Education has recently voted to join the Ohio Valley Educational Cooperative and have ratified the Interlocal Agreement, and

NOW THEREFORE IT IS AGREED BY THE MEMBER SCHOOL DISTRICTS EXECUTING THIS AMENDMENT THAT THE ORIGINAL INTERLOCAL AGREEMENT AS PREVISOULY AMENDED BE AMENDED AS FOLLOWS:

#### X. Approval

Section X of the original agreement is hereby amended to read as follows: This agreement shall become effective after approval and execution by the participating boards of education and upon approval by the Commissioner of Education, and the Kentucky Attorney General. This Interlocal Agreement is entered into pursuant to the authority of KRS 65.210 to 65.300, inclusive.

Under Section IX of the original agreement as amended in 1976, provides that additional school districts may engage in this agreement by passage of a resolution complying with the conditions of this agreement and upon approval of the Board of Directors of the Ohio Valley Educational Cooperative. The Franklin County Board of Education has passed such a resolution complying with the conditions of the agreement and the Board of Directors has voted to approve their membership. The Franklin County Board of Education and all thirteen member boards of education have approved and accepted the provisions of the amended agreement and all other terms and provisions of the original agreement as previously amended, and hereby incorporated by reference.
