Approval of agreement with Torch Prep an ACT Test Prep to provide ACT practice test to Floyd County sophomores and juniors, aggregated data results, and two day ACT blitz for juniors.

Fiscal/Budgetary Impact:

The cost to the district for the 2018-2019 school year will be \$50,000.00, seventy-five percent of the total cost. The schools will pay the additional twenty-five percent, \$16,723.00, and their individual cost will be based on the number of juniors enrolled in their school. This cost includes an ACT Pre-Assessment for both sophomores and juniors, aggregated data results, and a two day ACT blitz for each school.

History/Background:
