EXECUTIVE SUMMARY

Our School Improvement Plan's major focus for the 2008-2010 is focusing on subpopulations while maintaining the high level of performance already demonstrated by the school as an entity. There will be a continued focus on *The Thoughtful Classroom* teaching model, refining the MAP assessment program, and working on improving our math program through differentiated instruction. School-wide professional development for 2008-2010 will focus on effective collaboration, writing, and implementation of authentic assessments. The Title I will concentrate on guided reading and writing in primary, with equal time given to both, writing in fourth grade, and literacy math in fifth. We will continue the E. S. S. daytime waiver option that will also be used in the language arts area.

In the remaining components of the SIP, Learning Environment Component strategies include focusing on providing a safer learning environment for students and improving working relationships and communication with parents. The Efficiency Component includes strategies to promote and invigorate the mission and vision for G. C. Burkhead through monitoring and meaningful feedback. Additionally, vertical and horizontal collaboration must occur when evaluating core content to ensure that all material is covered sufficiently.

The 2008-2009 Process of Developing the School Improvement Plan

- The mission statement was developed and approved by staff in 2002.
- The entire staff conducted a data analysis on the 2008 KCCT data during a school wide Professional Development day. The data analysis guidelines from the state department were used to analyze and disaggregate the test information.
- Along with the new data analysis information, 2008 NCLB test data, and SB 168 information were also considered as support for strategies and activities that needed to remain in the current school plan.
- Each committee devised an action plan based upon data analysis that included strategies to be used in the School Improvement Plan.
- A parent survey was issued to obtain input on school needs.
- Based on the information collected and reviewed, and the Standards and Indicators for School Improvement, the 2008-2010 School Improvement was updated.
- The new plan was submitted to the council at the October 21, 2008 site based council meeting.
- On October 21, 2008, the council reviewed and accepted the Priority Needs, Causes, Goals and Objectives, and Strategies and Activities at a public meeting.

How will the Comprehensive Improvement Plan and Other Important Information Be Shared with Stakeholders?

All stakeholders, i.e., parents, faculty members and community members, will be informed that copies of the plan are available in the school office or on the school and district website for their review. In addition, faculty members, PTA leadership, and SBDM Council members will be provided with a copy of the plan. Discussion of the plan and results of implementation of the plan will occur at SBDM Council Meetings and faculty meetings.

How will Input Continue to be Gathered from Stakeholders?

Information will be gathered from stakeholders through the SBDM Council Meetings, PTA Meetings, and faculty meetings. Additional input from stakeholders will occur through surveys. A review of midcycle assessment results will be conducted by the faculty and SBDM Council in the fall of 2009 and reviews of impact information will be conducted at SBDM Meetings each year.
