EXECUTIVE SUMMARY

Heartland Elementary opened its doors for the first time in August of 2008. Heartland's student population was compiled from three neighboring elementary schools; GC Bulkhead, Lincoln Trail, and New Highland. All three schools performed well on Kentucky's State Assessment and two of the three schools met their AYP under No Child Left Behind. The three schools that Heartland pulled from are also schools that have successfully been implementing strategies from the Thoughtful Education process.

As Heartland's identity in the Hardin County School system evolves, we have started to focus on many of the same instructional strategies and programs common to the three schools above as well as other schools in our district. The focus of our professional development and faculty/team meetings has been on implementing Thoughtful Ed strategies, MAP data analysis and differentiating instruction. Rather than delegate leadership roles to certain individuals a goal for our school is to build capacity among ALL teachers so that we can learn from each other and support each other in the areas of curriculum, instruction, and assessment.

Heartland is a Title 1 school and will use these funds to help all students in the areas of reading, writing and math. Heartland has been approved for the ESS Daytime Waiver program in which funds will be used to hire assistants to help students who struggle in the areas of reading and math.

In opening a new school it is very important that team building and trust be established among all faculty, staff, students, parents and community. Therefore developing relationships will be priority in the area of learning environment. For the first year, Heartland will focus on establishing rituals and traditions that build a positive school culture that exhibits high expectations and strong school pride.

The activities listed on the next few pages will help align Heartland with the common practices evident in the other elementary schools in our district. Moreover, these activities will begin to build a strong foundation necessary for our school to provide a quality education that prepares students for life.

Since Heartland would not have any Kentucky assessment data or NCLB data at this time, the following priority needs and goals will be the same as the district. The activities our school has developed align with the district focus and also help get Heartland established in the areas of Academic Performance and Learning Environment.
