8 STATUTORY AUTHORITY: 156.070, 156.160, 156.162

9 NECESSITY, FUNCTION, AND CONFORMITY: KRS 156.160 requires the Kentucky Board

10 of Education to establish courses of study for the different grades and kinds of common schools,

11 with the courses of study to comply with the expected goals, outcomes, and assessment strategies

12 developed under KRS 158.645, 158.6451 and 158.6453. KRS 156.162(4) requires the Kentucky

13 Board of Education to include course standards in the program of studies for Kentucky schools.

14 KRS 156.070(1) requires the Kentucky Board of Education to manage and control the common

schools and all programs operated in the schools. KRS 160.290 authorizes local boards of

16 education to provide for courses and other services for students consistent with the

17 administrative regulations of the Kentucky Board of Education. KRS 156.162 requires the

18 Kentucky Board of Education to promulgate an administrative regulation for course standards for

- 19 an elective social studies course on the Hebrew Scriptures, Old Testament of the Bible; the New
- 20 Testament of the Bible; or a combination of the Hebrew Scriptures and the New Testament of the

1 Bible. This administrative regulation incorporates by reference the Kentucky Academic 2 Standards for Historical and Cultural Influences of the Bible Elective Social Studies Course. 3 Section 1. Schools offering an elective social studies course on the Hebrew Scriptures, Old 4 Testament of the Bible; the New Testament of the Bible; or a combination of the Hebrew 5 Scriptures and the New Testament of the Bible shall meet the minimum content requirements 6 established in the Kentucky Academic Standards for Historical and Cultural Influences of the 7 Bible Elective Social Studies Course. Section 2. Incorporation by Reference. (a) What this administrative regulation does: KRS 156.162 required the Kentucky Department of Education (KDE) to develop course standards for an elective social studies course on the Hebrew Scriptures, Old Testament of the Bible; the New Testament; or a combination of the Hebrew Scriptures and the New Testament of the Bible. This regulation fulfills the requirements of KRS 156.162.

(b) The necessity of this administrative regulation: KRS 156.162 required the Kentucky Department of Education (KDE) to develop course standards for an elective social studies course on the Hebrew Scriptures, Old Testament of the Bible; the New Testament; or a combination of the Hebrew Scriptures and the New Testament of the Bible. This regulation fulfills the requirements of KRS 156.162.

(c) How this administrative regulation conforms to the content of the authorizing statute: The regulation conforms to KRS 156.162 by creating the course standards for an elective social studies course on the Hebrew Scriptures, Old Testament of the Bible; the New Testament; or a combination of the Hebrew Scriptures and the New Testament of the Bible as required by the statute. Also, the administrative regulation conforms to 158.197 by providing course standards if a School-Based Decision Making (SBDM) council wants to offer this elective class for grades nine through twelve.

(d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: The regulation conforms to KRS 156.162 by creating the course standards for an elective social studies course on the Hebrew Scriptures, Old Testament of the Bible; the New Testament; or a combination of the Hebrew Scriptures and the New Testament of the Bible as required by the statute. Also, the administrative regulation conforms to 158.197 by providing course standards if a School-Based Decision Making (SBDM) council wants to offer this elective class for grades nine through twelve.

(a) List the actions that each of the regulated entities identified in question (3) will have to take to comply with this administrative regulation or amendment: The standards outlined in 704 KAR 3:306 are standards for Historical and Cultural Influences of the Bible Elective Social Studies Course. No public schools, school districts, or school councils are required to offer this course. Therefore, no action is required on their part unless they offer the elective course. If they do choose to offer the course, they will be required to follow the standards outlined in the document incorporated by reference in 704 KAR 3:306. Any course offering will be expected to follow all applicable laws and federal and state guidelines in maintaining religious neutrality and accommodating the diverse religious views, traditions and perspectives of students in the school and any course offering shall not endorse, favor, promote, disfavor or show hostility toward any particular religion, non- religious faith or religious perspective.

(b) In complying with this administrative regulation or amendment, how much will it cost each of the entities identified in question (3): The standards outlined in 704 KAR 3:306 are standards for Historical and Cultural Influences of the Bible Elective Social Studies Course. No public schools, school districts, or school councils are required to offer this course. Therefore, no action is required on their part unless they offer the elective course. The Department does not typically create standards for elective courses, however, since the development of those standards was required by statute, the Department spent approximately \$1,200.00 as of the date of filing in the development of the standards in addition to staff time. Additional staff time will be needed as the regulation moves through the legislative and implementation process.

(c) As a result of compliance, what benefits will accrue to the entities identified in question (3): The standards outlined in 704 KAR 3:306 are standards for Historical and Cultural Influences of the Bible Elective Social Studies Course. No public schools, school districts, or school councils are required to offer this course. However, if the course is offered, public schools must comply with 704 KAR 3:306. The regulation provides public schools with the standards to be taught in the event the course is offered.

(5) Provide an estimate of how much it will cost the administrative body to implement this administrative regulation: The standards outlined in 704 KAR 3:306 are standards for Historical and Cultural Influences of the Bible Elective Social Studies Course. No public schools, school districts or school councils are required to offer this course.

(a) Initially: The standards outlined in 704 KAR 3:306 are standards for Historical and Cultural Influences of the Bible Elective Social Studies Course. No public schools, school districts, or school councils are required to offer this course. Therefore, no action is required on their part unless they offer the elective course. The Department does not typically create standards for elective courses, however, since the development of those standards was required by statute, the Department spent

approximately \$1,200.00 as of the date of filing in the development of the standards in addition to staff time. Additional staff time will be needed as the regulation moves through the legislative and implementation process. No public schools, school districts, or school councils are required to offer this course.

4. Summary of Comments and Responses

- (1) Subject Matter: Conform to the current language of the learning goals in KRS 158.6451 as amended by the General Assembly in 2009 in the *Kentucky Academic Standards for Historical and Cultural Influences of the Bible Elective Social Studies Course* and other standards documents.
- (a) Comment: The commenter stated that Page 4 of the *Kentucky Academic Standards for Historical and Cultural Influences of the Bible Elective Social Studies Course* needs to be amended to accurately reflect the language of learning goals set forth in KRS 158.6451, specifically goal 2, as amended by the General Assembly in 2009.
- (b) Response: The Department carefully considered the comments.

In 2009, the Kentucky General Assembly revised the goals listed in KRS 158.6451 through the passage of SB 1 (2009). Prior to 2009, goal 2 in KRS 158.6451 read, "Apply core concepts and principals from mathematics, science, arts and humanities, social studies, English/language arts, health, practical living including physical education, to situations they will encounter throughout their lives". This goal is listed in the front matter of the document incorporated by reference in 704 KAR 3:303 and was inadvertently transferred over to the *Kentucky Academic Standards for Historical and Cultural Influences of the Bible Elective Social Studies Course* document.

The Department appreciates the comments from the Kentucky Coalition for Arts Education and will amend the *Kentucky Academic Standards for Historical and Cultural Influences of the Bible Elective Social Studies Course*, page 4 to correct this inaccuracy. The Department will also update the language of the capacities and other learning goals that have changed.

- (2) Subject Matter: Addition of learning goal 7 to standards documents.
- (a) Comment: The commenter expressed a desire for learning goal 7, added by the General Assembly to KRS 158.6451 in 2009 through the passage of SB 1 (2009), be added to the list of learning goals listed on page 4 of the *Kentucky Academic Standards for Historical and Cultural Influences of the Bible Elective Social Studies Course.*
- (b) The Department carefully considered the comments.

This goal was inadvertently omitted from the front matter of the document incorporated by reference in 704 KAR 3:303; therefore, when the learning goals were transferred over to the *Kentucky Academic Standards for Historical and Cultural Influences of the Bible Elective Social Studies Course* document, learning goal 7 was omitted. The language in the document incorporated by reference will be updated to conform to KRS 158.6451.

Summary of Statement of Consideration And Action Taken by Promulgating Administrative Body

The agency proposes the following amendments to the document incorporated by reference:

Page 3, Kentucky's Vision for Students Insert new bullet under "capacities and learning goals" "Core values and qualities of good character to make moral and ethical decisions throughout his or her life;"

Page 4, "capacities and learning goals" have been updated with gender neutral language

Page 4, Learner goal 2 from KRS 158.6451 that read,

"Apply core concepts and principles from mathematics, science, arts and humanities, social studies, English/language arts, health, practical living, including physical education, to situations they will encounter throughout their lives" has been updated to read, "Apply core concepts and principles from mathematics, the sciences, the arts, the humanities, social studies and practical living studies to situations they will encounter throughout their lives"

Page 4, the language in other goals has been updated to align with statute.

Page 4, Learner goal 7,

"Express their creative talents and interests in visual arts, music, dance and dramatic arts" that was inadvertently omitted, was added.
