The Center is also developing a proposal to be micro-credentialed in the area of financial literacy that would benefit both graduate level students and also high school students (as they would receive college credit also).

Special Education Update:

New DoSE Joining the Region- We have had several transitions in our network and are excited to welcome Mrs. Marta Scott as the new Assistant Director of Special Education in Kenton County.

DoSE Advisory Committee: The DoSE Advisory group met on August 22 and reviewed plans for the upcoming academic year. They stated their support for the current leadership plan and offered to help during the transition by attending additional state meetings.

IDEA Grant- NKCES submitted the IDEA Grant Application with recommended revisions to KDE on July 30. KDE has stated they plan to wait to make final decisions on IDEA grants for 2018-2019 until they have reviewed every Co-op's grant proposal. The last review was scheduled to happen on August 27 and we are awaiting word on their approvals of our grant.

Regional DoSE- On August 13, Mrs. Diane Hatfield and Dr. Laura Clarke attended the state Co-op Directors meeting in Frankfort and brought back key information to the region. State co-op directors stated their support for our staff during this year of transition and shared resources and suggestions for ways our co-ops can continue to build capacity across the state to support special education initiatives.

IEP Compliance trainings- Dr. Kim Weber and Dr. Laura Clarke provided more than 27 hours of IEP Compliance trainings for districts. In addition, Dr. Dusty Columbia Embury provided 12 hours of IEP trainings for regional teachers. An additional three fall IEP trainings for the region are upcoming.

Threat Assessment Train the Trainer: NKCES sent Dr. Laura Clarke, Dr. Patrick Richardson, and Ms. Tabatha Marsh from RSP to the Co-op sponsored Threat Assessment Training in Lexington on August 14-16. An October 16 date has been secured for a regional training. This training will be facilitated by Dr. Clarke and Dr.

Richardson.

Youth Mental Health First Aid Training: Dr. Laura Clarke and Literacy Consultant Ms. Alison Teegarden attended this Train the Trainer workshop on August 28-30 in Frankfort. This training was sponsored by

This training is a complement to the Trauma Informed Care work and Multi-Tiered Systems of Support (MTSS) Interconnected Systems Framework (ISF) initiatives that are part of the PBIS and wraparound school supports for students with challenging behaviors and behavior disorders served under IDEA

VI Services- For the 2018-2019 SY, our program will serve approximately 35 students with visual impairments. Currently services and evaluations are underway to start the school year. Ft. Thomas has added VI services and the funding formula is being reworked to account for a change in total number of school districts and students participating in this program.

Professional Learning (PL) Update:

August Professional Learning: NKCES provided a total of 79 professional learning opportunities during the month of August serving 1,120 educators.

Fall Professional Learning: NKCES will provide a comprehensive menu of professional learning focused on academics, culture and climate, and special education.

Continuous Improvement/eProve - NKCES is partnering with KDE to host this training on October 16 in our training room.

Mind Shift: Moving from a Culture of Teaching to a Culture of Learning - NKCES is partnering with KDE's Continuous Improvement Coaches to provide this training on December 6 at Ralph Rush Center.

Professional Learning Communities (PLCs): NKCES will support nine PLCs for the upcoming school year including: Arts & Humanities, Media Specialists, English Learners, Physical Education, Preschool, School Counselors, Special Education Consultants, Special Education Teachers and Instructional Coaches. PLCs provide opportunities for educators to grow professionally in a collaborative environment focused on collective learning.

Regional Schools Program (RSP) Update:

RSP and NKU's partnership for the fall is getting ready to begin on 9/14/18.

English Learners (EL) Program Update:

The EL Consultants presented K-5 and 6-12 sessions of *Engaging English Language Learners* at the Fort Thomas Independent Schools PD Academy on the 10th and 13th. We would be glad to present a session for your school or district as well. Please contact either EL Consultant to make arrangements. Our Kagan for ELs Workshop has reached capacity. We plan to offer additional PD opportunities to meet your needs and welcome your input.

Our Title III Application has been submitted in GMAP. PSPs have been developed for all returning students. We are currently assessing new students and developing their PSPs and meeting with administrators, teachers, and parents to ensure that students' language needs are being met. As always, we appreciate the opportunity to serve your districts.

NKY Institute for Arts Education (NKIAE):

Letters regarding funds to implement arts integration at participating schools have been sent to superintendents, district finance officers, and school principals. Teacher participants have received feedback on the arts-integrated plans they developed during our summer workshop, and they are now scheduling follow-up meetings and classroom observations with Project Manager Mr. Joe Bertucci. Participants can engage in an online forum and participate in arts experiences throughout the year to continue their professional learning. National Arts in Education Week is September 9 -15.

Grant Consortium Update:

<u>KDE/Duke Energy Foundation:</u> The \$25,000 received from Duke for the career connection plan will be augmented with funding from the state. These funds

contributed to the hiring of our Career Connector, Ms. Helen Carroll.

<u>Innovative Approaches to Literacy:</u> Three proposals were submitted for \$750,000 per year for three years (for each proposal), announcement pending in late September/ early October.
