This screenshot below shows list price of the CR cylinder (which includes an integrated core) originally specified compared to the SFIC less core cylinder we interpreted the architect wanted on all exterior openings. This cylinder would accept the Schlage Restricted small format keyed cores specified for exterior openings. At a standard 50% discount on each mfr, the difference in price would be \$7.50, however the additional discount we got through the project pricing for the original CR cylinders made them a wash with the new SFIC cylinders provided. We did not provide any pricing for new cores at the exterior openings as they were indicated to be reused. If we had priced new Schlage SFIC Restricted cores those would have increased the cost of the change substantially as those cores have a list price of \$82.00 for just the core.


