Background: Trigg County Public Schools adopted 09.313 AP.1 Drug Testing of Student Athletes, as a result of this adoption; the District is seeking proposals from reputable vendors and/or businesses to assist in the compliance of this policy.

Quoted prices for services must be effective beginning September 27, 2018 and extend through June 30, 2019. Trigg County Schools retains the right to extend the awarded contract for services for up to three (3) more years in one-year increments from July 1, 2019, if applicable and with agreement of the service provider.

RFP PROCESS

Sealed bids will be received at the office of the Trigg County Schools, 202 Main Street, Cadiz, KY 42211, until 3:00 p.m.CST, September 6, 2018, for Student Athlete Random Drug Testing. All bids are subject to the terms and conditions of the bid invitation and must be received in sealed envelopes with the following identification:

SCOPE OF SERVICES

Data Management

- 1. Advise the District of any changes in Federal/State requirements with respect to random student drug testing and act as subject matter expert on related issues.
- 2. Provide federally required record keeping, reporting, verification and inspection of records.
- 3. Design and implement random selection procedures.
- 4. Respect the confidentially of this highly sensitive information.

Specimen Collection Services

- 1. Provide on-site urine specimen collection.
- 2. Provide for proper chain of custody and all necessary forms (i.e. Medical History, Consent to Test and Custody) relating thereto.
- 3. Provide collection supplies.
- 4. Monitor collection procedures and protocols of the Federal Substance Abuse and Mental Health Services Administration (SAMHSA) Standards.

Laboratory Services

- 1. Provide a 9 Panel Drug Test with pH Nitrate.
- 2. Should the initial test result in a positive for any drug or drug metabolite, provisions must be made for a confirmatory test in a certified laboratory.
- 3. Provide proper documentation and storage of a portion of each specimen by the laboratory for at least six (6) months.
- 4. Written confirmation of all test results shall be forwarded by the testing laboratory to the District Office Coordinator and school principal.
- 5. The laboratory shall re-test if there is a positive first test.

Bids for these services are subject to the following conditions:

The successful bidder agrees to have each employee who will work on school premises in the District submit to a national and state criminal history background check and have each employee obtain a letter from the Cabinet for Health and Family Services stating the employee has no findings of substantiated child abuse or neglect pursuant to the requirements of KRS 160.380(7). The successful bidder agrees to obtain this information at no additional cost to the District and shall supply this information to the District prior to each employee working on school premises in the District.
