The attached contract is for professional development/consulting services with Envision Learning Partners from Oakland, California. Envision Learning Partners provides consulting for college and career readiness assessment systems, K-12 by assisting districts and schools with the creation of graduate profiles aligned to competency-based assessments. A district team representing a variety of roles within our district have participated in trainings and work sessions throughout the 2017-2018 school year which resulted in the draft of a Profile of a Graduate for Bullitt County Public Schools. The next phase in this work is to provide "listening and learning" sessions to gain feedback from different stakeholder groups that represent our school and community. The goal for the scope of the contract work is to conduct a session, faciliated by a consultant from Envision Learning, with our district instructional coaches to gain feedback. After this session, the district team will assist with facilitation of more "listening and learning" sessions modeled after the initial session. In addition, Mr. Bacon and the Student Learning Department will meet with the consultant and plan next steps for the Profile of a Graduate framework aligned to competency-based indicators for Grades K-12 combining elements of the Individual Learning Plan (ILP) as mandated by the law. The rise of personalized learning, assessment movement towards competencies and grant funding opportunities offered through the KDE on competency-based systems it is essential we provide training to gain a thorough understanding of this work and assistance for implementation, as appropriate. The total cost of all Envision Learning Partners services is \$3,750 including travel. All training and planning work will be in person. Funding source is Title II funds.
