SUMMARY OF ISSUE BEFORE THE BOARD:

To take action on the Office of Career and Technical Education Policy Adoptions and Amendments.

COMMISSIONER'S RECOMMENDATION:

The Commissioner recommends essential workplace program policies be adopted as part of curriculum and instruction (Chapter 8). The Commissioner also recommends existing policies related to personnel (Chapter 3) and students (Chapter 9).

APPLICABLE STATUTE OR REGULATION:

KRS 156.070, KRS 156.802

BACKGROUND:

Existing Policy: The KDE and the schools have been working with the Kentucky School Boards Association (KSBA) to consider model policies. Policies and procedures for the OCTE are updated annually to reflect laws passed during the legislative session. These policies provide consistency and are consistent with school districts across the Commonwealth.

The KBE has previously approved the following policies over the past several years. KSBA organizes policies by chapter. The following chapters have already been adopted for OCTE:

Chapter 1 – Powers & Duties of the Board

Chapter 2 – Administration

Chapter 3 – Personnel

Chapter 4 – Fiscal Management

Chapter 5 – School Facilities

Chapter 7 – Support Services

Chapter 8 – Curriculum & Instruction

Chapter 9 – Students

Chapter 10 – Community Relations

Summary of Issue: Attached amendments relate to chapters 3, 8, and 9. A chart is attached explaining the proposed changes.

Budget Impact: Possible fiscal impact includes less compensatory time for teachers.


GROUPS CONSULTED AND BRIEF SUMMARY OF RESPONSES:
