


Hopkins County YMCA Usage Agreement with Hopkins County Schools

October 2018-March 2019

- The YMCA provides pool time Monday-Friday between 3:15pm & 6:15pm. Hopkins County Central High School will practice in the pool from 3:15pm-4:45pm. Madisonville North Hopkins High School will practice from 4:45pm-6:15pm. During this time, participants swim under the direction of their high school coach.
- The YMCA hosts Swim Lessons on Tuesday/Thursday night. High School swimmers need to be out of the pool by 6:15pm.
- The Dive Team may use the pool on Monday evenings after 6pm or Tuesday & Thursday evenings after 7:30pm. The pool is not closed during this time. Early mornings before school hours are also available, as are Saturdays at 10am. Dive team only has access to the deep end of the pool as the Y will have private swim lessons held in the shallow end at times. Dive team practice times should remain the same throughout the season.
- The Hopkins County School System must provide the YMCA with a Certificate of Insurance.
- The high school coaches are Hopkins County Board employees and are not responsible for supervising YMCA members during practice time.
- Coaches must contact the Aquatics Director to schedule a KHSAA compliant start date.
- Coaches must provide the Aquatics Director with a roster by October 15, 2018. The annual usage rate is \$13,250.
- Any scheduling changes (school breaks, holidays, etc) must be discussed and approved by the Aquatics Director.
- The Aquatics Director must approve dates and times for scheduling home meets. If schools wish to host more than 4 meets in a year, it must be approved by the Aquatics Director (additional meets may only be scheduled and at an additional fee). Schools may not schedule home meets in the same week.
- It is the responsibility of the host school to prepare for a meet. This requires setting up prior to the meet, bringing all necessary copies/materials & cleaning up after the meet.
- Coaches must be First Aid, CPR & Lifeguard certified. Coaches will provide the YMCA with these current cards.
- The YMCA reserves the right to deny privileges to any swimmer/coach due to misconduct at the pool.
- Coaches must remain with swimmers after practice until all have been picked up. Only swimmers with a YMCA membership and release form on file with the school can be left unattended.
- The coaches are responsible for proper care, usage & storage of equipment. The YMCA is not responsible for any lost or damaged equipment.
- Coaches are responsible for monitoring use of the locker rooms before and after practices. Swimmers should clean up after themselves after using the locker rooms.
- The coaches are responsible for putting lane lines in and taking them out.
- During practices, at least one lane must be made available to YMCA members for lap swim only. A YMCA Lifeguard will be on deck during this time.
- Swimmers must rinse off in the locker room showers prior to entering the pool.
- Swimmers must dry off after practice prior to entering the building.
- The YMCA aquatic staff is responsible for maintaining the pool water and facility.
- The YMCA aquatic staff has the right to cancel practices/meets due to inclement weather. If schools are cancelled due to inclement weather, coaches may still hold practice if Hopkins County Schools allows afternoon/evening practices. The safety of swimmers and coaches should always come first.
- The Aquatics Director shall be the main contact for any pool related issues. Any issues will be resolved as quickly as possible.
