2017-18 Transition Period -Moving from Old to New Model

- 2017-2018 is the first year of transition period to a new accountability model.
- For 2017-2018, schools will be identified as Comprehensive Support and Improvement (CSI), Targeted Support and Improvement (TSI), or Other (not CSI/TSI).
- Next Year: New 5-Star Rating System Begins



Identification of CSI

CSI I-Bottom 5%

- School must perform below the cut score on each indicator
- School may perform below cut on one or two indicators and not be identified as CSI
- **CSI II-Graduation Rate**
- Automatic if 4-year graduation rate is below 80%
- One additional school was identified

Total six (6) high schools for CSI I and CSI II

TSI Entrance Criteria

Tier I Targeted Support (Early Warning): Consistently Underperforming Student Group(s): One or more student groups performing as poorly as <u>all students</u> in any of the lowest performing 10% of Title I schools or non-Title I schools (by **Targeted** level – elementary, middle or high school) based on school performance **Support** for two consecutive years (identified annually, beginning in 2020-2021). and **Tier II Targeted Support (Low Performance):** Low-performing Student Improvement Group(s): (TSI) One or more student groups performing as poorly as all students in any lowest performing 5% of Title I schools or non-Title I schools (by level –

(identified annually beginning 2018-2019).

elementary, middle or high school) based on school performance

Accountability Standard Setting

- An Accountability Standard Setting was held on August 22 to determine threshold cut scores for CSI.
- Kentucky is required to identify schools for Comprehensive Support and Improvement (CSI) and Targeted Support and Improvement (TSI) for support beginning in Fall 2018 (based on 2017-2018 data)
- At least 5% of Title I schools must be identified for CSI
- No set amount required for TSI; TSI identification is any school with at least one student group performing below the CSI cut scores (determining CSI therefore automatically determines TSI)
