Re: TE21, Inc. (Learning Partners, LLC) Order Agreement

Attached you will find an order agreement between Bullitt County Public Schools and TE21, Inc which is a partner of Learning Partners, LLC. TE21, Inc. is an education company that offers CASE Benchmark Assessments aligned to College and Career Ready Standards/Common Core State Standards (CCSS), CASE Item Bank with over 70,000 high-quality standard-based items, intervention solutions, professional development, and a slate of other education improvement efforts for school and districts. We are contracting with TE21 to provide standards-based benchmark assessments at our two schools identified as CSI, Shepherdsville Elementary and Bullitt Lick Middle School. These assessments will be administered twice throughout the remainder of the 2018-2019 school year to all students in each school.

The purpose of this assessment implementation is to pilot working on an improved comprehensive assessment system across the district. These assessments are created to match the exact depth and rigor of the Kentucky Academic Standards in reading and math. In addition, teachers at these two schools will have access to an assessment item bank which will be used for formative and summative assessments. Professional learning is also embedded into the agreement to assist teachers with understanding and effective implementation of the assessments and analysis of data. This contract also supports our current work utilizing the AdvancED Standards for Schools as a framework to facilitate improvement of our instructional processes and assessments systems for improved student success. The total cost of the order agreement is \$15,799 which includes the item bank, professional learning, paper/pencil assessments administered twice, and online access for both schools. The funding source is carryover Title 1 funds. This order agreement has been reviewed by Eric Farris of Buckman & Farris. Board approval is requested for the order agreement between BCPS and TE21, Inc.
