Re: Request for Board Approval

I am requesting permission accept funds from the Division of Family Resource and Youth Service Centers for the following schools: Bullitt East High School, Eastside Middle School, Zoneton Middle School and Pleasant Grove Elementary School. The schools will received funding starting January 1, 2019. In addition, some of the centers will be reconfigured to increase financial viability and to have centers consistent with feeder patterns. All students in BCPS will then have access to a coordinator. The FY19 increase in funding to the Bullitt County FRYSC program will be approximately \$103,278.50.

Three additional coordinators will be hired to man newly formed centers. Starting January 1, 2019 the centers will be as follows:
