RE: SY 2018-2019 IDEA-B Notice of Approval (Stage II)

Dear Dr. Pollio:

The Kentucky Department of Education has received and reviewed the information provided relative to your 2018-2019 proposal for funding of the Special Education Division of the Greater Louisville Educational Cooperative. Based on the revised submittal of your proposal, the Kentucky Department of Education (KDE) is providing Notice of Approval (NOA) for Stage II funding.

This Stage II NOA approves the remainder of the Greater Louisville Educational Cooperative (GLEC) proposal funding, effective July 1, 2018. **The total amount available based on this approval is \$901,100.** This proposal is funded from Kentucky's Section 611 Grants to States allocation under Part B of the Individuals with Disabilities Education Act (IDEA), to provide technical assistance and support as directed and approved by the KDE, Division of Learning Services (DLS). The distribution and use of these funds are determined on an annual basis.

Federal laws governing the use of these funds are found in the 2004 IDEA Reauthorization at 20 USC § 1400, *et seq.*, and its implementing regulations (34 CFR Part 300), and in the Education Department General Administrative Regulations (EDGAR) at 34 CFR, Parts 74-86. Relevant state law is located in 707 KAR 1:015.

SY 2018-2019 IDEA-B funds can be requested using federal cash request forms obtained from the Division of Budget and Financial Management. These funds are available for obligation from July 1, 2018 through September 30, 2019 provided the cooperative has:


- Spent all SY 2017-2018 IDEA-B funds;
- Met all supervision requirements related to IDEA-B projects;

- Submitted a current, approved proposal on file with the Division of Learning Services; and,
- Special conditions are not imposed on these funds.

SY 2017-2018 IDEA-B funds previously approved, may not be spent after September 30, 2018 unless they have been properly obligated and reported. Unpaid obligations of SY 2017-2018 funds must be liquidated by November 30, 2018 and the deadline to submit your final request for reimbursement is December 10, 2018. Any funds not requested by this time will revert back to the U.S. Department of Education.
