DISTRICT FACILITIES PLAN HEARING REPORT**

A public hearing was held at the Owsley County Board of Education Central Office on September 11, 2018 at 5:45 P.M. The purpose of the public hearing was to propose a new District Facility Plan developed by the Owsley County Local Planning Committee. The Local Planning Committee (LPC) voted 9 number in favor and 0 number opposed in favor of the proposed new plan and the Board voted 5 number in favor and 0 number opposed to approve the new plan.

There was/were 0 individual(s) in attendance. Chad Mason, Transportation Director/Buildings & Grounds, served as the locally-appointed hearing officer, NONE was/were present.

COMMENTS

Chad Mason called the public hearing to order. The hearing officer outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 4:180.
