## F. Good News Report

- 1. Chairperson Carolyn McDaniel reported that the Volleycats were doing excellent and had made it to Regionals.
- 2. Our Bobcats in football has won the District Championship.

**ABSENT** 

- 3. There has been an improvement in the BHS band.
- 4. The teachers were actively on duty at the correct times and places as assigned.
- 5. Senior banners have come in and looked great above the Stadium.
- 6. Teacher Attendance was good.
- 7. The BHS Choral Members would be having a concert at Kelsey's on Main, Wednesday, October 18, 2018 and they along with the band, have raised almost

\$1800.00 in donations for new uniforms.

# II. Planning Reports

- A. Comprehensive Support and Improvement (CSI)-
  - 1. Mr. Watts stated that we a Stay Together, Work Together Partnership. The Council will run as normal. However, final decisions would be made at the Board level. BHS as a whole is a CSI school and we need to focus on those 7<sup>th</sup> and 8<sup>th</sup> grade students. The middle school has not met their delivery target in 5 years.
  - 2. Stacey Davidson defined CSI in detail and how to get out of CSI status.
  - 3. Superintendent Phillip Watts stated that this has been our first year being labeled a Priority School.
  - 4. State Manager Mike Murphy stated that our kids deserve better. Being in the bottom 5% is not acceptable.
  - 5. Tara Hall has noticed that with the middle school teachers are "so down" and the morale is low and they seem "hurt."
  - 6. Carolyn McDaniel stated that after talking with a veteran teacher, they are willing to change their thought process on accountability and are willing to work to get the students where they need to be.
  - 7. Roberts Shouse stated that he would like to point out that there had been a lack of altercations with the middle school students thus far compared to the previous years. He agrees that combining the middle school with the high school was the best idea for the students and as a teacher that worked at both schools on a daily basis, he could see a big difference in how they behave.
- B. Monthly Review of Comprehensive School Improvement Plan (CSIP)
  - 1. 1<sup>st</sup> part is completed concerning the student and parent surveys.
  - 2. 2<sup>nd</sup> part- Teachers are working with teams and identifying what assessments need to be completed. (ABRI, PEBIS)
  - 3. Encouragement of student made personal goals via the guidance office.
  - 4. The practice ACT was just given and the teachers need to use that information as bell ringers for their classrooms.

# C. Monthly Budget Report

- 1. The monthly budget report was unavailable and had not been provided. Patricia Gross stated that she had just been introduced to the MUNIS program and would have the reports at every meeting.
- 2. Superintendent Phillip Watts recommended that Patricia Gross partner with Secretary of LBJ, Beth Davidson for some possible training.

## D. Academic Reports

# E. Behavior Report -
