- 1. A maximum of six (6) lanes will be leased and hired by the above named high school consisting of _____ teams for a period of no less than one 2-hour practice per week beginning after October 1, 2018, ending on February 8, 2019. KHSAA allows teams to host two (2) scrimmages prior to the start of the season. These scrimmages must be held on a practice day.
- 2. A maximum of 18 weekly competitive matches shall bowl every Thursday beginning on November 1, 2018 and ending January 17, 2019. There may be a second competition date set during the week as necessary to complete the schedule. Competition starts promptly at 3:30 pm with practice starting 10 minutes prior to the scheduled starting time. The telescores will automatically be started at the scheduled practice time. Should a high school require a later starting time they must request the change in starting time with their host facility at the time of the completion of the master schedule.
- 3. The high school through its school administration shall pay the center for rental of the lanes at the rate agreed to per team per season (\$550 per team). If a high school fields both a boys and girls team the total cost would be a two-team rate per season. League fees shall be paid to the host facility no later than November 30, 2018. Any extension needed for payment of these fees must be negotiated with the host facility but are payable no later than December 31, 2018.
- 4. The bowling center offers the following services that are included in the fees:
 - a. One (1) 2-hour practice session per week on the day of the week negotiated with the host facility
 - b. Use of bowling center equipment necessary for the bowlers to compete (house bowling shoes and house bowling balls) while in the host facility
 - c. Competitive matches weekly beginning no earlier than November 1, 2018 and ending no later than January 17, 2019.
- 5. It is understood and agreed by the parties that postponements due to severe weather, holidays, and acts beyond the control of the center or the high school which prevent the use of the lanes by the league, shall release the center and/or high school from any responsibility for damage or claims of any nature whatsoever. It is also understood any postponements or delays for above-mentioned reasons, at the request of the high school, shall result in the high school making up all competitive sessions missed at a later date.
- 6. A minimum of two lanes will be kept open between high school bowling and open play. One pair of lanes will be set aside for practice use during the regulation games on the day of competitive matches when possible.
- 7. Additional services available upon request are:
 - a. Hosting of invitational tournaments by host facility schools. Fees associated with these invitational tournaments will be set with the mutual agreement of the host school and the host center.
 - b. Additional weekly practice sessions at a cost of \$5,00 per bowler per session.
- 8. Regional tournament events are the responsibility of the assigned school and all costs associated with this event will be negotiated with the host facility. The regional host schools for the 2018/19 season are: Region 5 Pendleton County; Region 6 Covington Catholic. The host school will meet with their selection for a host facility a minimum of 60 days prior to the event to work out details and prices.
