This Memorandum entered into by and between _Trigg County Board of Education_ and Crittenden County Board of Education, 601 West Elm Street, Marion KY, 42064.

Witnessed that for and in consideration of the mutual benefit of the parties, the parties do hereby agree to as follows:

Purpose of the Agreement. The purpose of this agreement is to clarify that oral memorandum of Agreement concerning services to be provided to the _Trigg County_ School District by Crystal Moore, TVI (Teacher of the Visually Impaired) employee of the Crittenden County Board of Education. Mrs. Moore will perform professional duties for the _Trigg County Board of Education_ for _1/2_ (hours/days per week/month) for the school year 2018-19 beginning January, 2019 and ending May 2019. The term of agreement shall cover the 170 day school calendar that will be in effect. The time to be worked by Mrs. Moore will be determined by the Director of Special Education.

Duties: The duties shall include providing visually impaired services per the Crittenden County Job Description.

Payment: The _Trigg County_ School District shall reimburse the Crittenden County School District the amount of _\$130.04_ per day. This reimbursement will be made to the Crittenden County Board of Education in two equal payments. One in March 2019, the other in June 2019. Invoices will be sent and payment returned to Diane Winters, Director of Finance, Crittenden County Board of Education. Trigg County will also be required to make 1 payment of \$1,250.00 to the University of Kentucky on February 1st 2019 and 1 payment of \$1,250.00 on September 1st 2019 (pending 2019-2020 school year contract agreement) to cover the tuition of Crystal Moore.

Additionally, the _Trigg County Board of Education_ will reimburse Mrs. Moore mileage to and from her home and to all school facilities that she must serve in _Trigg County_ and this payment will be made directly to Mrs. Moore by the _Trigg County_ School District based upon Trigg County's mileage rate.
