I. Call to Order

Chairman Mark Myers called the meeting to order at approximately 6:02 pm.

II. Public Comment

Parent Larry Damron stated that Band Director Scott Bersaglia was a credit to the community and good for the students in the district.

III. Student Achievement

A. Student/Staff Recognition

Principal Booher introduced Junior Ross Damron as one of fifteen students across the state to be named to All State Band in Percussion.

Superintendent Green introduced Mr. Charles "Frosty" Davis as the new Director of Pupil Personnel and Ms. Ashla Samples as the new Director of Special Education.

B. PES Principal's Report

Principal Robert Jones announced that PES was the first elementary school in our area to be designated as an entrepreneurial school. Mr. Jones reviewed progress with benchmark assessments in Reading and Math. He also explained the progress of revisions to the school writing policy.

C. PHS Principal's Report

Principal Jason Booher gave a demonstration of the new Pikeville Independent Schools App that has multiple functions including staff contacts, academic and athletic events, and school announcements. Mr. Booher also provided updates on various academic and athletic events.

D. Instructional Supervisors' Report

Instructional Supervisor Mary Belcher reviewed the Consolidated District Improvement Plan (CDIP) and provided an overall picture of areas of concentration for academic improvements within the district.

Instructional Supervisor Johnny Belcher noted possible changes within the state to graduation requirements for next school year.
