#### CONTRACT FOR NONRESIDENT PUPILS

#### **Instructions:**

- Contracts are required by KRS 157.350, which reads in part: "Each district which meets the
  following requirements shall be eligible to share in the distribution of funds from the fund to
  Support Education Excellence in Kentucky (SEEK). A school district may not include
  nonresident pupils in its average daily attendance (ADA), except by written agreement with
  the district of the pupil's legal residence.
- 2. Each district is to keep a signed copy of this contract on file.
- 3. The board of education of the district where the nonresident pupils attend school agrees to make attendance reports at the close of the first two (2) months and at the close of the school term. These reports shall be delivered to the board of education where the pupils legally reside and shall agree with the terms of this contract.
- 4. The board of education of the district of residence and the board of education of the district providing instruction agree that all contractual terms, supplemental agreements, and other conditions governing this exchange of students are herewith fully disclosed. Copies of all such contracts, agreements, and conditions are attached and made part of this contract for non-resident pupils.
- 5. Contract may be written to read "any", "all", or a specific number of students, subject to restrictions of the local board of education (attach copy of local board policy).
