THIS MODIFICATION, made and entered into as of this 13th day of March, 2019, by and between the Greater Louisville Workforce Development Board, Inc. d/b/a/ KentuckianaWorks, 410 West Chestnut Street, Suite 200, Louisville, Kentucky 40202 ("the Board"), as the Administrative Entity for the Greater Louisville Workforce Development Board and the Board of Education of Jefferson County Kentucky, 3332 Newburg Road, Louisville, Kentucky 40232 ("the Contractor").

W I T N E S S E T H:

Modification to Previous Agreement :

Pursuant to Part 11, "Modifications to Agreement," the parties to this Modification Agreement No. 1 mutually agree to make the following modification to the Original Agreement previously entered into by and between the Board and the Contractor in Contract No. 500-150-19.

The purpose of this modification is to make the following budget adjustments:

- Remove one Career Development Assistant position for remainder of year;
- Add capacity for extended days for staff;
- Adjust salary and fringe for several staff positions to ensure they are in line with updated JCPS projections;
- Adjust indirect cost rate, from 2.96% to 3.25%, to account for minor yearly increases; and

- Increase several Operational Cost line items—Educational Materials and Participant Expenses—with savings from salary and fringe adjustments noted above.

These changes are outlined in the attached budget. Note that these changes result in a reduction of \$3,164.46 to the original, approved budget. The difference will be returned to KentuckianaWorks. The new budget for this contract will be \$217,096.95.

APPROVED AND CERTIFIED: To be a grant of funds previously approved by the Mayor of the Louisville/Jefferson County Metro Government, or his authorized representatives, and the Greater Louisville Workforce Development Board, Inc., as contained in the Greater Louisville Workforce Development Area's Workforce Development Plan; or to be a grant of funds in accordance with procedures contained in the Inter-local Cooperation Agreement between the Louisville Jefferson County Metro Government and the Counties of Bullitt, Henry, Oldham, Shelby, Spencer, and Trimble.
