3. Kentucky Youth Career Center Internship Academy Worksite Agreement

This request allows BCPS to participate in Kentuckiana Works' Kentucky Youth Career Center Internship Academy. Student interns may be placed in any school in an effort to establish an employment history and to gain work experience which will leave them better positioned to obtain an unsubsidized job when the experience ends. There is no cost to the schools or to the district. Mr. Eric Farris reviewed and approved the agreement.
