On January 31, 2019 bids were received from roofing contractors for the 2019 Hopkinsville High School Partial Reroofing (200 Wing) project, BG # 18-273. A copy of the bid tabulation is attached.

Five bids were received, with Preferred Construction Services, Inc. submitting the low bid of \$295,950.00. This bid was 3.8% (\$10,950.00) above the BG-1 probable cost. This is within a reasonable range of estimated probable cost to actual bid.

If the Christian County Board of Education wishes to proceed with this project, they should, at their February board meeting, take the following actions:

- 1. Accept the low bid from Preferred Construction Services Inc., Henderson, Kentucky of \$295,950.00 and subject to KDE approval, enter into a contract with Preferred Construction Services Inc. Henderson, Kentucky in the amount of \$295,950.00.
- 2. Approve a revised BG-1 reflecting the contract amount and submit to KDE via FACPAC.
- 3. Email JKS a copy of the board minutes.
