RE: Non-Resident Contract Trigg County

The Office of Pupil Personnel seeks the recommendation of the Christian County Board of Education regarding the Non-Resident Contract between Christian County Public Schools and Trigg County Public Schools. The attached non-resident contract for the 2019-2020 school year includes identical stipulations as the 2012-2013, 2013-2014, 2014-2015, 2015-2016, 2016-2017, 2017-2018 & 2018-2019 approved non-resident contracts by the Christian County Board of Education. Please review the attached 2019-2020 non-resident contract.

The 2019-2020 Non-Resident Contract Stipulations include the following:

- Christian County will release ADA (including transportation credit) to Trigg County for non-resident students who attended Trigg County as a non-resident student from Christian County during the 2012-2013 school year.
- There is no provision for sharing ADA (including transportation credit) for siblings (born or unborn) by Christian County.
- In accordance with HB 182, the district will share ADA for whose parents/guardians work in the nonresident district.
- Trigg County and Christian County waive the right to appeal or contest these terms during the 2019-2020 school year.
- This is a one year only agreement for the 2019-2020 school year, with each district reserving the right to take a different position in future years.

KENTUCKY DEPARTMENT OF EDUCATION CONTRACT FOR NONRESIDENT PUPILS 2019-2020 School Year

Instructions:

- 1. Contracts are required by KRS 157.350, which reads in part: "Each district which meets the following requirements shall be eligible to share in the distribution of funds from the fund to Support Education Excellence in Kentucky...(4) Includes no nonresident pupils in its average daily attendance, except by written agreement with the district of the pupils legal residence..."
- 2. This contract is to be made in triplicate. One copy is to be filed with the Kentucky Department of Education, together with the attendance report for the first two (2) months of the school term. Each district is to keep a signed copy on file.
- 3. The board of education of the district where the nonresident pupils attend school agrees to make attendance reports at the close of the first two (2) months and at the close of the school term. These reports shall be delivered to the board of education where the pupils legally reside and shall agree with the terms of this contract.
- 4. The board of education of the district of residence and the board of education of the district providing instruction agree that all contractual terms, supplemental agreements, and other conditions governing this exchange of students are herewith fully disclosed. Copies of all such contracts, agreements, and conditions are attached and made part of this contract for nonresident pupils.
- 5. Do either parents or either board of education pay tuition for nonresident children? "YES "NO. If "YES", attach a statement disclosing the tuition rate, to whom it is paid and the payment terms.
- 6. Contract may be written to read "any", "all", or a specific number of students, subject to restrictions of the local board of education (attach copy of local board policy).

- I. The board of education of the <u>Christian County</u> school district (district of legal residence of pupils) enters into a contract with the board of education of the <u>Trigg County</u> school district (district where the pupils attend) to educate <u>select pupils</u> (list on back of contract or attach list). This contract further provides that the average daily attendance of the pupil(s) is to be counted in the district where the pupil(s) attendschool.
- II. The board of education of the <u>Trigg County</u> school district is to receive transportation credit for <u>select pupils</u> reported in Part I, such credit to be calculated in accordance with KRS 157.370.
