Lesson Plans

Truth & Consequences is a drug prevention program for 8th graders, designed and facilitated through the University of Kentucky Extension Office. 8th grade students from Mt. Washington Middle (walking across S. Bardstown Rd.) and Eastside Middle (bus transport) will cycle through three workshops with their parents:

(1)Simulation- each student is issued a card with a situation involving ATOD and navigate through the consequences, visiting applicable agencies while learning the impact it has on their health, freedom, educational process and employability. The following agencies have committed to be at tables stationed around the gymnasium: Judge Porter & Family Court associates, DJJ, Law Enforcement, First Responders, Treatment Facilities, Bullitt County Jail, Counselors and BOE staff.

(2) *I Was You*: An Alumni Panel from a certified drug treatment program called Program REACH will present the realities of drug experimentation in high school, their road to recovery and how addiction impacts health, lifestyle, families, employability, finances, etc. (3) *The Long Road of Addiction*: Students watch a short documentary threaded with group discussion to explore positive coping skills, drug epidemiology and the biochemical aspects of dependency.

Mt. Washington Middle School will walk over and attend the program from 8:10-11:10 AM and Eastside from 11:30:-2:30PM. Students will complete a writing piece once they are back at school. They will chose one of the following writing prompts:

~Write a letter to a guest speaker or panel member thanking them for sharing their story with remarks of courage and how their story will change how you live your life.

~Write a letter to at least one of the agency representatives that assisted you with your drug or alcohol situation in the CLC gym: judge, law enforcement, health services, treatment center, jail, etc. Thank them for volunteering, share 2 things you learned and describe how what you learned will change your decisions in the future.
