- **Start-Up Activities.** The first set of performance goals is to complete the start-up activities for the Agency to begin delivering power and transmission service on May 1, 2019. The start-up activities involve completion of the infrastructure and processes to ensure the Agency is fully operational.
- **Steady State Operation.** The second set of performance goals is the move the Agency into steady state operation by implementing best practices in functional areas across the Agency.






