#### I. Call to Order

#### C. 2019-2020 SBDM Allocations

Superintendent Green presented the 2019-2020 SBDM allocations for both schools. Mr. Green explained the Elementary School allocation is for one less certified staff member due to the significant decrease in enrollment there. PHS certified staffing allocation would remain the same as enrollment has slightly increased for them. Superintendent Green also shared funding allocations to remain at \$152 per student compared to the state required \$100.
