Wiring upgrades with Erate funding

Our Erate funding for infrastructure improvements is winding down. The upcoming 2019-2020 school year is the final year for funding with this 5-year cycle. In the past 4-years we have upgraded nearly all network switches, network cabling, WiFi access points for dense wireless coverage to meet the demands of our 1:1 initiative, UPS battery backups for wiring closets, and our data center. We still have approximately \$234,192.64 in funding left, so I have filed for wiring upgrades additional network switches for schools with significant budget amounts left.

The cost for the additional switches will be \$144,224.64, and the cost for the wiring will be \$62,308.00 or a total combined cost of \$206,532.64. This will leave an unspent balance of \$27,660.00, for which we will relinquish these funds since we have purchased everything that we feel is currently needed for the district. There were restrictions on what we could purchase, and based on the allowable products we chose (wiring, switches, access points, cabling, connectivity equipment and UPS backup systems).

The Erate program will reimburse us for 80% of the \$206,532.64, less deductions for preschool students of \$949.10. District costs will be approximately \$42,255.63 with the balance of \$164,277.01 to be paid by Erate.

I received wiring proposals from four companies listed on the attachment "price comparisons". The lowest proposal was Business Cabling Systems, LLC (BCS) which has performed most of our recent cable installs for Mt. Washington Elementary, Maryville, Bullitt Lick and Bullitt Central. Business Cabling System's price to wire four schools is \$62,308.00, with the next lowest price by KEDC of \$77,206.77. Based on price, I will declare Business Cabling Systems, LLC as the low bidder and recommend the Board approve them for the this Project. I have attached the simplified contract with BCS which needs to be signed by the Superintendent. Joe Mills has reviewed and approved this contract.

In addition, since network switches are being purchased from the state KETS Networking Contract, I sent our requirements to those vendors and choose (Extreme) formally Avaya as the vendor. Dell was offered an opportunity to bid, but could not provide an acceptable solution to our current network environment. If you have any questions, please let me know.

The Kentucky Educational Development Corporation, herein after KEDC, and Bullitt County Public Schools, herein after District, agree to enter into this contract for Technical Services of eligible items as determined by the Eligible Services List for Funding Year 2019. The District's eligible systems includes, but is not limited to, local area networks (LANs), wireless local area networks, routers, uninterruptible power supplies, network switches, access points, wireless LAN controllers, cabling, racks, caching servers, firewalls, system improvements and upgrades, managed internal broadband services, etc. The Technical Services shall be provided on contractual and/or time and materials basis.

#### KEDC agrees to provide the following services to the District:

#### **Basic Maintenance Services**

KEDC will provide Technician(s) for the repair and upkeep of eligible hardware, wire and cable
maintenance, basic technical support, and configuration changes. See below for an itemized list of covered
products.

#### Installation Services

• KEDC will provide Technician(s) for installation and initial configuration of the eligible products listed below.

#### Applicable To All Services

- KEDC agrees to provide liability insurance for the KEDC employee working in the district.
- KEDC agrees to invoice the Schools and Libraries Corporation for the discounted amount of services provided and bill the District for their portion of services.

#### The District agrees to:

#### **Basic Maintenance Services**

- Pay KEDC rates listed below for 8 hours of billable time for Basic Maintenance Services as needed. (Billable time includes travel time to and from the district and on-site time.)
- Provide a minimum of 6 hours of billable time per technician, per trip on-site.
- Pay KEDC the SLC discounted amount of the invoice in the event the Schools and Libraries Corporation denies payment of a funding commitment after service is rendered (Net 30).
- Pay KEDC invoices Net 30.

#### Installation Services

- Purchase materials necessary to complete the project.
- Pay KEDC upon completion of the project installation.
- Pay KEDC the SLC discounted amount of the invoice in the event the Schools and Libraries Corporation denies payment of a funding commitment after service is rendered (Net 30).
- Pav KEDC invoices Net 30.

This term of this contract may be extended by mutual agreement of both parties. KEDC agrees to allow SPIN changes in the event KEDC no longer provides the services requested in this contract. This contract is contingent upon funding approval from the Schools and Libraries Universal Service Fund (E-Rate).


