## **Rowan County SCHOOL DISTRICT DISTRICT FACILITIES PLAN HEARING REPORT\***

A public hearing was held at the **Rowan County Board of Education Central Office** on **2/20/19**, at **5:30 PM** (local time). The purpose of the public hearing was to propose a new District Facility Plan developed by the **Rowan County** Local Planning Committee. The Local Planning Committee (LPC) voted **13-0** in favor of the proposed new plan and the Board voted **5-0** to approve the new plan.

There were to (2) **persons at the hearing exclusive of the hearing officer** individual(s) in attendance. **Glen Teager, CFO and chair of LPC**, served as the locally-appointed hearing officer. **Peter Fisher of Ross-Tarrant Architects and Andy Conyers, RCBE Technology coordinator** were present. No public members attended and therefore there were no comments or suggestions to the DFP.

## **COMMENTS**


**Glen Teager** called the public hearing to order. The hearing officer outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 4:180. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. The hearing officer read the proposed new District Facility Plan which includes; **a major renovation to the Viking Center (currently KCTCS) for the purpose creating an Early Childhood Center, a renovation of said Viking Center for creating an Alternative School in the current biennium. Renovations to Clearfield Elementary School, Rodburn Elementary, Tilden Hogge, and the Rowan County Senior High School. Minor renovations to McBrayer Elementary School.**

The floor was opened to those who wished to make a statement. **As no public attended, there were no comments or suggestions for the DFP. Recording of opening of meeting will be submitted.**

## **RECOMMENDATIONS**

It is recommended that the new District Facility Plan as developed by the **Rowan County** Local Planning Committee and adopted by the **Rowan County** Board of Education be approved as the District Facility Plan for the **Rowan County** School District. A copy of the new plan is attached.
