TODD COUNTY SCHOOL DISTRICT
DISTRCT FACILITIES PLAN HEARING REPORT*

A public hearing was held at the **Todd County Board of Education** on **February 19, 2019**, at **5:31p.m.** (local time). The purpose of the public hearing was to propose a new District Facility Plan developed by the **Todd County Schools** Local Planning Committee. The Local Planning Committee (LPC) voted **13-0** in favor of the proposed new plan and the Board voted **5-0** to approve the new plan.

There were **10** individual(s) in attendance. **Mr. Bruce Voth**, Principal of North Todd Elementary School served as the locally-appointed hearing officer. **Edwin Oyler, Jennifer Pope, Camille Dillingham, Troy Winders, Rhonda Werner, Christopher Brandon, David Carmichael, Billy Bingham, Yvonne Rundall, and Amanda Jordan** was present.

COMMENTS

Mr. Bruce Voth called the public hearing to order. The hearing officer outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 1:001. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. The hearing officer read the proposed new District Facility Plan which includes; TCCHS renovation to provide a secure entrance and admin suite addition/renovation, roof replacement, renovation to gym, HVAC in all 1963 and 1968 only (excluding gym), plumbing, lighting upgrade, CCTV, intercom and fire alarm systems. TCMS renovation to include providing a secure entrance, site drainage, asphalt paving, brick repair on canopy, interior finishes throughout, roof, exterior stair, and exterior door replacement. Upgrade to gym, HVAC and controls, plumbing, lighting upgrade, CCTV, intercom and fire alarm systems. North Todd Elementary renovation to include providing ADA signage, replacement of door hardware, asphalt paving and repairs, masonry repairs, interior finishes, roofing and flashing, providing a secure entrance, lighting upgrades, CCTV, fire alarm and intercom. South Todd Elementary renovation to include providing ADA signage, replacement of door hardware, asphalt paving and repairs, masonry repairs, interior finishes, roofing and flashing, providing a secure entrance, lighting upgrades, CCTV, fire alarm and intercom. Todd County Horizons Alternative School renovation to include lighting upgrades and CCTV. District White Board Initiative to provide fixed active boards and projectors in all classrooms district wide with wireless capability for hand-held student assessments and remote operation. Central office major renovation to include interior finishes, ceiling tile in board room, window replacement, settlement crack repairs, HVAC and CCTV. Asphalt paving at maintenance and district storage building. Bus garage major renovation to include ADA toilets, asphalt paving, add 2 lifts, HVAC and controls, drinking fountains, plumbing, power upgrades and CCTV.

The floor was opened to those who wished to make a statement. **No comments were made.**

RECOMMENDATIONS

It is recommended that the new District Facility Plan developed by the Todd County Schools Local Planning Committee and adopted by the Todd County Board of Education be approved as the District Facility Plan for the Todd County School District. A copy of the new plan is attached.
