Professional Learning (PL) Update

March Professional Learning: NKCES supported a total of 76 professional learning opportunities focused on academics, culture and climate and special education during the month of March serving 626 educators.

PL Consortium: A subcommittee was established to collaborate regarding the Essential Workplace Ethics Program. The PL Consortium also discussed possible regional opportunities and common curriculum needs.

Dreamfest: Dreamfest was a success this year with more than 600 students participating. The day included session with 40 + presenters from across the region. The support from volunteers from our school and community partners help create the rich learning environment for all.

Edcamp: On Saturday morning, March 9th, **400** educators from across Northern Kentucky (and several from neighboring counties) joined together for a morning of learning from each other organically. This regional Edcamp was hosted by BallyShannon Middle School and sponsored in part by NKCES and the Northern Kentucky Education Council. The event included donations courtesy of Children's Inc, Dunkin' Donuts, and Biggby Coffee. Next years NKY Edcamp is scheduled for February 29, 2020 at Northern Kentucky University.

Word Nerds: On March 21st, we had our first training session in our new space. Word Nerds was offered to the entire region for educators needing research-based strategies for vocabulary and sight word retention. In attendance were educators from 10 different districts. Participants included special education teachers, general education teachers, intervention teachers, and instructional coaches.

SNAP Math Training: NKCES is committed to empower our regional Special Education Teachers and Instructional Coaches in Early Numeracy through SNAP (**S**tudent **N**umeracy **A**ssessment **P**rogressions) training. This past January and February we partnered with Beth Miracle-Meiman to bring SNAP training to the region. This a two-day course that provided professional development in administering and analyzing concise, diagnostic, individual assessment in early numeracy. Topics included number words and numeral identification, structuring, and addition and subtraction strategies. This formative assessment system provides a way to track

individual and group performance and enables teachers to differentiate instruction based on the results. SNAP is most appropriate for pre-kindergarten through first grade classroom and special education teachers.

Members practiced self-care techniques and shared positive implementation experiences in their home schools including promoting advisory/focus period/ curriculum through a shared folder on Schoology.

Regional Schools Program (RSP) Update:

RSP and TLC hosted our second Regional Alternative Program Collaborative Meeting on 3/14/19. We look forward to having these become a PLN opportunity next school year for the region!

RSP finished our annual LLS fundraiser on 3/29/19.

Kroger Community project plans to tour RSP first week of April to determine planning for their summer project.

RSP staff and students participated in a daily gratitude journal challenge, culminating with an ice cream party and special edition RSP gratitude t-shirt for those that participated.

English Learners (EL) Program Update:

On March 5th and 6th, we hosted a Kagan for ELs workshop at Gateway. More than 100 educators attended, and the session was well received.

We have been providing direct services to students. Information about our Family Literacy project has been distributed to the districts in our Title III Consortium. Students are selecting books to read with their families, and these books will be delivered in April and May.

In April, ACCESS scores will be released and we will be setting up meetings with our districts to review the scores and to plan for student services for the 2019-20 school year.

NKY Institute for Arts Education (NKIAE):

In the month of March, we observed lessons integrating the arts with ELA at Mary Goetz Elementary, Newport Primary, Lincoln Elementary, Newport Intermediate, Holmes Middle, and Silver Grove. We also offered two virtual professional learning sessions, focused on integrating theatre with ELA, using Zoom.

Our regional Steering Committee met on March 6 and March 25 to plan our 2019-20 Program: Integrating the Arts with Math. There are currently over 100 educators, on 22 teams, from 18 schools, in 9 districts, participating in our arts/math program. Participants have begun three hours of virtual learning in Google Classroom, to prepare for our summer workshop, scheduled for July 22 - 25.
