## AN ORDINANCE AMENDING THE CITY OF MOREHEAD, KENTUCKY CODE OF ORDINANCES, TITLE 11, BUSINESS REGULATIONS, CHAPTER 113, ALCOHOLIC BEVERAGE CONTROL SECTION 113.08(J), HOURS FOR SALE AND CONSUMPTION OF THE CITY OF MOREHEAD CODE OF ORDINANCES TO CLARIFY THE HOURS OF SALES BY RETAIL PACKAGE DISTILLED SPIRITS, WINE AND MALT BEVERAGE LICENSEES

WHEREAS, the hours for sale on Sunday by Retail Package Distilled Spirits, Wine and Malt Beverages Licensee is not correct in the current ordinance, City desires to extend the hours that restaurants or bars may sell alcohol by the drink;

**NOW, THEREFORE, BE IT ORDAINED** by the Board of City Council of the City of Morehead, Kentucky that Title 11, Business Regulations, Chapter 113 Alcoholic Beverage Control, Section 113.08(J), Hours for Sale and Consumption shall be amended as follows:

## Section 113.08 Hours for Sale and Consumption

(J) Hours for sale and consumption.

(1) Retail package distilled spirits, wine and malt beverages licensees shall be permitted to sell Monday through Saturday at all hours except for the period between the hours of 12:00 midnight and 6:00 a.m. prevailing time, and on Sundays <u>at all hours except for the period</u> between 12:00 midnight and 12:00 p.m.

(2) A licensee for distilled spirits, wine and/or malt beverages by the drink shall be permitted to sell or dispense alcoholic beverages by the drink Monday through Saturday, from 6:00 a.m. to 1:00 a.m. of the following day, and on Sunday from 12:00 p.m. to 1:00 a.m., on Monday, provided that the appropriate licenses and approvals have been obtained from both the city and the state ABC Board.

(3) Consumption of alcoholic beverages on licensed premises may not continue for more than thirty (30) minutes after the respective hours set forth herein for sales to stop.
