Andrew Owens with Sherman, Carter, Barnhart Architects was present to provide an update on Gateway Academy/Breathitt Center Renovations and Additions. Mr. Owens updated the board on the work completed and what work is in progress and stated that the project is on schedule.

**INSTRUCTIONAL UPDATE: STRIVING READERS UPDATE**

Amy Wilcox, Chief Instructional Officer; Kadi Ralston, Striving Readers Comprehensive Literacy Grant Coordinator/K-12 Literacy Coach; Brooke Stinson, Principal, Freedom Elementary School and Johnne Mercado, Teacher, Christian County High School were all present to give the board an update on the Striving Readers Grant and how the implementation process is working.

**LONG-RANGE PLANNING UPDATE**

Mary Ann Gemmill, Superintendent, gave the board a Long-Range Planning Update. She stated as the nickel initiative moves forward, a lot of information circulating social media is false. She provided the board with both HVAC and Roofing Long-Range Plans that the district completed several years ago showing that we do have long-range plans and target funding toward facilities. Ms. Gemmill thanked board members and community members that are attempting to address the false rumors that are circulating. She stated that she and staff members are speaking at community events to share the district's truth and clear up misinformation. She states they have been very transparent with data and will continue to get the district's truth to the public. Ms. Gemmill stated they will continue to go anywhere they are invited to speak.

## COMMITTEE REPORTS

### Mr. Clark

Mr. Clark stated he has not received a legislative update, however, he stated that Senate Bill 1 will be another mandate for the district with no funding for this year, but possible funding for next year. He said that the Bill seeking a tax write off for private school has died in committee.

### Mr. Bell

Mr. Bell stated they are continuing to look at Parent and Student survey results and best practices for meeting our improvement goals next year. Mr. Bell stated the word for March is ***Dedicated***. He mentioned we are in the last quarter of the school year and wants everyone to finish strong. He also stated he is taking part in a book study with the Chamber of Commerce called Life Long Learning. They are using the information in the book to improve communication of the factual information regarding the need of a new high school in the district.

### Mr. Moore

Mr. Moore stated he was unable to attend the PBIS meeting that took place this morning but he was given an update by Ms. Kim Stevenson, District Discipline Administrator. He stated the district has started their structure for Tier 2 and class referrals are in line with where they need to be. Teachers and Staff have done a good job and things are going well.

### Ms. Hayes

Ms. Hayes stated the Code of Acceptable Behavior committee met today to work on the 2019-2020 Code. She stated they discussed many issues, all of which will be brought before the board for approval at a later date.
