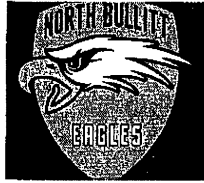

North Bullitt High School is writing to recommend the addition of an agriculture teacher position for the 2019-2020 school year at 240 days per year, which includes 53 extended days. The addition of this new pathway came about through a student survey, which resulted in high student interest in Animal Science. After the survey, several students approached the administrative team about starting Future Farmers of America (FFA) at NBHS. A proposal was submitted to NBHS SBDM on January 10, 2019 and approved by a council consensus. The addition of an agriculture pathway is not only exciting for North Bullitt High School, but for the Hillview community.
